TransCanada PipeLines Limited (TransCanada) – Application for approval of Amended Interim Tolls for the TransCanada Mainline effective 1 June 2008

The National Energy Board has examined TransCanada's application dated 9 May 2008 for approval of amended Mainline Interim Tolls to be effective 1 June 2008. This application is supported by Unopposed Tolls Task Force (TTF) Resolution 05.2008.

The Board has decided to approve the amended interim tolls as filed and directs that they be made effective 1 June 2008, pending a final order by the Board concerning TransCanada's 2008 Mainline Tolls.

The Board notes that TTF Resolution 05.2008 contemplates the establishment of a final 2008 revenue requirement and final tolls effective 1 July 2008 in addition to the interim toll amendment. The Board will consider these matters upon receiving TransCanada's final tolls application and may establish a comment period prior to issuing a final toll order.

TransCanada is directed to serve forthwith a copy of this letter and Order AO-04-TGI-01-2007 on all of its Mainline shippers and TTF Members.

## **ORDER AO-04-TGI-01-2007**

**IN THE MATTER OF** the *National Energy Board Act* (Act) and the regulations made thereunder; and

**IN THE MATTER OF** an application filed with the National Energy Board by TransCanada PipeLines Limited (TransCanada) dated 9 May 2008 pursuant to subsection 19(2) and Part IV of the NEB Act for approval of Mainline interim tolls effective 1 June 2008 under file OF-Tolls-Group1-T211-2007-10 05.

**BEFORE** the Board on 22 May 2008.

**WHEREAS** the Board approved an application by TransCanada, dated 16 November 2007 and supported by unopposed Tolls Task Force (TTF) Resolution 13.2007, and issued Order TGI-01-2007 authorizing the Mainline interim tolls effective 1 January 2008;

**AND WHEREAS** the Board approved an application by TransCanada, dated 25 January 2008, and issued amending Order AO-01-TGI-01-2007 amending the Mainline's interim tolls to include a Short Notice Balance toll for the Eastern Zone effective 1 January 2008;

**AND WHEREAS** the Board approved an application by TransCanada, dated 8 February 2008, and issued amending Order AO-02-TGI-01-2007 amending the Mainline's interim tolls to correct the calculation of the daily delivery pressure charges effective 1 January 2008;

**AND WHEREAS** the Board approved an application by TransCanada, dated 18 March 2008, and issued amending Order AO-03-TGI-01-2007 amending the Mainline's interim tolls to adjust for undercollection of revenue and for changed forecast volumes effective 1 April 2008;

**AND WHEREAS** under section 60(1)(a) of the Act; TransCanada filed errata on 10 April 2008 revising some interim tolls,

**AND WHEREAS** TransCanada filed an application dated 9 May 2008 proposing to increase the level of the Mainline interim tolls, effective 1 June 2008, in accordance with TTF Resolution 05.2008;

**AND WHEREAS** the Board has considered TransCanada's application dated 9 May 2008 and has decided to approve the application as filed;

## **THEREFORE, IT IS ORDERED**, pursuant to subsection 19(2) and Part IV of the Act, that:

- 1. TransCanada's current interim tolls, which were made effective under Toll Order AO-03-TGI-01-2007, and by the 10 April 2008 errata filing under section 60(1)(a) of the NEB Act, be terminated as of the end of the day on 31 May 2008; and
- 2. TransCanada's proposed tolls, as contained in its application dated 9 May 2008, be implemented effective 1 June 2008 on an interim basis pending a final order by the Board concerning TransCanada's 2008 Mainline tolls.
