ORDER AO-001-TG-003-2013

IN THE MATTER OF the *National Energy Board Act* (Act) and the Regulations made thereunder; and

IN THE MATTER OF an application for approval of Revised 2013 Final Tolls for Transmission in Zone 4, dated 13 June 2013, filed by Westcoast Energy Inc., carrying on business as Spectra Energy Transmission (Westcoast) pursuant to Part IV of the Act, under File OF-Tolls-Group1-W102-2013-02 01.

BEFORE the Board on 18 June 2013.

WHEREAS on 18 January 2011, the Board approved an application by Westcoast, dated 17 December 2010, and issued Order TG-01-2011 authorizing the 2011 to 2013 Negotiated Toll Settlement, effective 1 January 2011;

AND WHEREAS on 7 March 2013, Westcoast filed an application pursuant to Part IV of the Act for approval of 2013 final tolls;

AND WHEREAS on 26 March 2013, the Board approved Westcoast's 2013 final tolls by Order TG-003-2013;

AND WHEREAS on 13 June 2013, Westcoast filed an application pursuant to Part IV of the Act for approval of Revised 2013 final transmission tolls for Zone 4 (Application);

AND WHEREAS the Board has considered Westcoast's Application, and having found the tolls to be just and reasonable, has decided to approve the Application as filed;

THEREFORE, IT IS ORDERED, pursuant to Part IV of the Act, that:

Westcoast's proposed revised transmission tolls for Zone 4, as contained in its Application dated 13 June 2013, are approved as final, effective 1 July 2013 to 31 December 2013.
