**NOVA Gas Transmission Ltd. (NGTL)  
Request for Partial Relief from Order TG-05-2010 with respect to the Alberta  
System 2010-2012 Revenue Requirement Settlement (Settlement)**

The National Energy Board (Board) has considered NGTL's 3 February 2011 application requesting partial relief from the timing requirements set out by the Board in Order TG-05-2010, for filing Tolls, Tariff, Facilities and Procedures Committee (TTFP) reporting documents specified in Section 2(F), items (ii) to (v) of the Settlement. Specifically, NGTL requests relief to file these documents by March 31, rather than March 1, of each year during the term of the Settlement.

The Board finds NGTL's request to be reasonable and, therefore, has decided to approve the requested partial relief as filed.

The Board directs NGTL to serve a copy of this letter on all of the Alberta System shippers and members of its TTFP.

**ORDER AO-1-TG-05-2010**

**IN THE MATTER OF** the *National Energy Board Act* (Act) and the regulations made thereunder; and

**IN THE MATTER OF** an application by NOVA Gas Transmission Ltd. (NGTL) dated 3 February 2011, for approval of Partial Relief from Order TG-05-2010 pursuant to section 21 of the Act, filed with the National Energy Board under File OF-Tolls-Group1-N081-2010-02 01.

**BEFORE** the Board on 24 February 2011.

**WHEREAS** the Board, on 24 September 2010, issued Order TG-05-2010 approving, among other things, a settlement that establishes the annual revenue requirement of the Alberta System for the three years 2010 to 2012 and certain deferral accounts (Settlement);

**AND WHEREAS** the Board, in Order TG-05-2010 directed NGTL to file with its annual surveillance reports a copy of the Tolls, Tariff, Facilities and Procedures Committee (TTFP) reporting documents specified in Section 2 (F), items (ii) to (v) of the Settlement;

**AND WHEREAS** the Board requires an annual surveillance report to be filed no later than 60 days after the year-end;

**AND WHEREAS** NGTL filed an application dated 3 February 2011 requesting partial relief from the timing requirements set out by the Board in Order TG-05-2010, for filing TTFP reporting documents specified in Section 2(F), items (ii) to (v) of the Settlement. Specifically, NGTL requested relief to file these documents by March 31, rather than March 1, of each year during the term of the Settlement;

**AND WHEREAS** the Board has determined that the requested partial relief is reasonable;

**THEREFORE, IT IS ORDERED THAT** unless the Board otherwise directs, NGTL shall:

- a) continue to file with the Board its annual surveillance report no later than 60 days after the year end, and
- b) file a copy of the TTFP reporting documents specified in Section 2 (F), items (ii) to (v) of the Settlement no later than March 31 of each year during the term of the Settlement.
