Letter of Decision on the Filed Statements of Opposition to the Proposed Detailed Route of the Pipeline for Segment 7

Background Information

On 19 May 2016, the National Energy Board (the Board) issued a report recommending that Governor in Council (GIC) approve the Trans Mountain Expansion Project (TMEP), subject to 157 conditions (A77045). On 29 November 2016, GIC approved the TMEP and directed the Board to issue Certificate of Public Convenience and Necessity OC-064 (Certificate).

On 9 December 2016, Trans Mountain filed its draft Plan, Profile, and Book of Reference (PPBoR), sample Notices for service, and its publication plan (A80988). On 10 February 2017, the Board approved these documents (A81698).

With this approval, Trans Mountain began publishing Notices with information about the detailed route approval process in local newspapers along the pipeline route, and providing a copy of the publication Notice and the Board letter of 10 February 2017 to various Aboriginal groups. Trans Mountain noted in its 16 June 2017 letter to the Board (A84459) that the final date of publication in local newspapers was 6 June 2017. As provided in subsection 34(4) of the *National Energy Board Act* (NEB Act), persons, other than an owner of lands who anticipates that their lands may be adversely affected, had 30 days from 6 June 2017 to file a statement of opposition with the Board.

Trans Mountain was also required to provide hard copies of the relevant segmented PPBoR filings to local libraries, municipal offices and Indian Band offices, and to include details of the locations where the PPBoR filings can be viewed, in the published Notices.

Telephone/Téléphone: 1-800-899-1265 Facsimile/Télécopieur: 1-877-288-8803 Trans Mountain also began serving written Notice to landowners whose lands will be crossed by the pipeline. This Notice showed where the detailed route is proposed to cross the landowner's property and provided information on how the landowner can oppose the proposed route. Trans Mountain set out the last dates of personal service for each segment of the detailed route in its letter to the Board filed on 18 July 2017 (A85005). Landowners had 30 days from the date of personal service to file a statement of opposition with the Board.

During and following the time Trans Mountain was providing notification, landowners and persons, other than an owner of lands, who anticipates that their lands may be adversely affected were able to file with the Board a statement of opposition to the proposed detailed route in accordance with subsections 34(3) and 34(4) of the NEB Act.

As of February 2017, the Board made available on its website information about the NEB Act requirements for a statement of opposition, a template with additional instructions on the requirements for a statement of opposition, and instructions on how to file a statement of opposition. Process Advisors were available by email or phone to provide one-on-one support and answer any questions about the requirements and how to file the statement of opposition with the Board. The Process Advisors also held online tutorials about the detailed route approval process and the statement of opposition.

The Board received statements of opposition from a total of 452 interested persons for the entire TMEP detailed route.

Detailed Route Hearings for Segment 7

On 3 and 17 March 2017, Trans Mountain filed with the Board the specific sections of the PPBoR for Segment 7 (A81972) and (A82137) of the proposed TMEP pipeline route.

This Letter of Decision only considers those statements of opposition filed for Segment 7. The Board received statements of opposition from 135¹ interested persons related to tracts in Segment 7. The Board notes Trans Mountain did not file comments in relation to any of the statements of opposition filed for Segment 7.

A separate Letter of Decision on the statements of opposition for Segment 1 and Segment 2 was released on 31 August 2017 (A85764). A decision by the Board on the statements of opposition for the other segments in the TMEP detailed route process, being 3 through 6, will be issued at a later date.

Detailed Route Hearings Granted for the City of Burnaby

On 15 September 2017, the Board issued Ruling No. 2, granting detailed route hearings to the City of Burnaby for all of the lands opposed by the City of Burnaby (A86068). Accordingly, the Board has not reconsidered the City of Burnaby's two statements of opposition in this Letter of Decision. The City of Burnaby is noted in this Letter of Decision as a matter of convenience as sections of this Letter of Decision do apply to it as a landowner or affected person granted a detailed route hearing in Segment 7.

Overview of the Statements of Opposition for Segment 7

When assessing the statements of opposition, the Board applied the criteria provided in subsections 34(3), 34(4) and 36(1) of the NEB Act. The assessment was based on the information provided in the statements of opposition. The Board considered:

- 1) if the person opposing is a landowner as defined under subsection 34(3) of the NEB Act, or a person, other than an owner of lands, who anticipates that their lands may be affected as defined under subsection 34(4) of the NEB Act;
- 2) if the opposition was about the location of the detailed route, the timing and/or the methods of construction; and
- 3) if the opposition was filed on time according to subsections 34(3) and 34(4) of the NEB Act.

Statements of Opposition that met the Requirements of the NEB Act

In relation to Segment 7, the Board determined by this Letter of Decision that 27 persons who filed statements of opposition met the requirements of the NEB Act. The Board has previously granted, to the City of Burnaby, detailed route hearings in relation to the two statements of opposition it filed, with respect to its lands in Segment 7. Therefore, the Board has granted detailed route hearings for a total of 28 persons in Segment 7.

The Board grants a detailed route hearing for each of the Landowners or Affected Persons listed below² (and also listed in Appendix I to this Letter of Decision):

The Board issued a single Hearing Order on 4 October 2017, which is applicable to all the detailed route hearings for Segment 7.

You should refer to the Hearing Order, which will be provided to you, for information about your roles and responsibilities as a Landowner or Affected Person in a detailed route hearing, as well as for the steps and deadlines in the hearing process. The Hearing Order assigns an individual number for each detailed route hearing. Your individual number is also included in Appendix I of this Letter of Decision.

Being granted a detailed route hearing does not prevent you and Trans Mountain from continuing to negotiate or consult. Additional support is offered by the Board to support dialogue between a company and Landowners or Affected persons. For instance, you may be interested in the Board's Alternative Dispute Resolution (ADR) process.

An ADR process is uniquely tailored to individual needs and could take the form of a meeting between the Landowner or Affected Person, and Trans Mountain. To take advantage of ADR, both the Landowner or Affected Person, and Trans Mountain, must agree to take part. This process is voluntary and facilitated by trained Board staff, or by another neutral third party. The facilitator will assist those participating in ADR to develop a process that may help resolve issues related to the statement of opposition.

If you are interested in the Board's ADR services, a session can be scheduled at a location and time agreeable to the Landowner or Affected Person, and Trans Mountain. For more information about ADR options, please email ADR-MRD@neb-one.gc.ca or call 1-800-899-1265.

These statements of opposition did not meet the criteria set out in the NEB Act because they did not meet the criteria of section 34 or 36 of the NEB Act. The Board found they were:

- 1. lacking sufficient information for the Board to make a determination;
- 2. comments and information of a general nature and not specific enough to demonstrate the opposition was related to the location of the detailed route, the timing and/or the methods of construction; and/or
- 3. unclear about the impact of the TMEP detailed route on the lands or the interests in lands that the person who filed the statement of opposition has.

In Appendix II, the reasons explained above, have been noted next to each statement of opposition that did not meet the criteria for a detailed route hearing.

The Hearing Order issued by the Board provides an opportunity for those not granted hearings to apply to participate in the hearings that have been granted for others.

General Concerns and Themes raised in the Statements of Opposition that did not meet the Requirements of the NEB Act

The detailed route approval process takes into consideration issues related to the exact location, and methods and timing of construction of the pipeline. It does not reconsider the Board's original decision for the TMEP. As the Certificate for the TMEP has been issued, concerns related to the TMEP that fall outside of the detailed route approval process may be directed to Trans Mountain.

The Board notes that the statements of opposition listed above did not meet the criteria for a detailed route hearing; however, the statements did provide information about local and current concerns related to the TMEP. For the purposes of the Board's assessment of the statements of opposition, a statement that included the themes noted below fall under reasons #2 and #3 as to why the statement did not meet the requirements of the NEB Act for a detailed route hearing.

As part of its ongoing engagement for the TMEP, the Board encourages Trans Mountain to inform and engage with communities and residents within and immediately surrounding the TMEP corridor to provide relevant information and discuss the concerns raised in the statements of opposition.

Themes from the statements of opposition are summarized below. Included at the beginning of each of these theme sections are further comments from the Board as to why these concerns did not meet the requirements of the NEB Act for a detailed route hearing.

1) General opposition to the TMEP

As noted in the background section of this letter, the TMEP was recommended for approval by the Board and received GIC approval. The Board reminds participants to the process that the detailed route process is not an opportunity to review whether or not the TMEP should proceed. Some statements of opposition noted a general opposition to the TMEP, which cannot be reviewed through a detailed route hearing. Examples of these concerns noted in the statements of opposition include:

"I oppose the pipeline in its entirety."

"This pipeline only serves to enrich the shareholders of Kinder Morgan Trans [Mountain] pipeline. PLEASE DO NOT ALLOW THIS TO HAPPEN!"

"I have several concerns regarding the proposed route for the Kinder Morgan Pipeline, and do not approve of its construction."

"Clean energy is the only way to go. Oil companies are self-serving money insane companies that don't care about our future."

2) Potential impact to persons and property

The majority of statements of opposition referred to concerns about the TMEP's potential impact on persons, property and lifestyle. These concerns generally included a variety of reasons for opposition, as opposed to one single reason, and focused on the TMEP's potential indirect impact on everyday life, particularly during the construction phase. These concerns included potential effects on health, personal property, noise and traffic levels.

These concerns were general in nature. Specific concerns were not raised about the detailed route, timing and/or method of construction (#2). These statements of opposition did not show a direct link between the detailed route and the individual's lands who filed the statement of opposition and how those lands could be adversely affected (#3). Examples of these concerns include:

"I oppose the proposed route on the grounds that the unsafe conditions created by the proposed route will adversely affect my life, my property, and my interests in the lands surrounding the proposed route."

"I am concerned for the health of my family, given the amount of dust and pollution that will be in the air from this work."

"I am especially concerned about the property values of my townhouse and the entire complex of 106 units."

"I believe our property values will be negatively affected by both the construction and the fact that a potential environmental hazard will be ultimately located less than a block away."

"We have worked hard to have our home quiet and safe and feel this is going to disturb all that."

"We have many concerns including devaluation of our property, impact on the environment around us and worries about health impacts."

"With construction nearby our daily commute will be severely interrupted as we have one way access only to our street that will hinder everyday travel."

"If the pipeline is going to be built, it will effect [sic] our home insurance, our property value and taxes."

3) Potential impact to the environment and one's ability to enjoy their surroundings

Some statements of opposition raised concerns about the potential impact of the TMEP on local urban natural areas, including impacts to wildlife (e.g., salmon), as well as local residents' ability to access and enjoy these natural areas.

These concerns are general in nature and are not sufficiently specific to meet the requirements of the NEB Act for a detailed route hearing (#2). Examples of these concerns include:

"Salmon habitats are already at risk. The proposed pipeline crosses through a salmon spawning creek."

"...we are concerned that the local roads, parklands, forests, bodies of water and conservation areas will all suffer damage."

"The impact on streams (may [sic] of which have been reclaimed for habitat) and the shrinking urban forest ecosystems will be devastating to the plants and animals that currently find habitat there."

4) Potential for safety concerns

The potential impacts of a natural catastrophe (notably, an earthquake) on an oil pipeline were raised in a number of statements of opposition. More generally, safety concerns about the potential impacts of a pipeline incident, emergency response and evacuation were also noted. Further, the concerns noted were general in nature and not specific to the detailed route or its impacts on lands (#2 and #3). Examples of these concerns include:

"We feel that our house is not a safe place to live anymore."

"There is too much risk in having a pipeline and oil tanks, and especially pipeline construction in this area...There is too much risk of oil spills, which are inevitable, that would run downhill through the community..."

"...we are concerned that emergency escape route could be extremely limited..."

"Any oil spill or unpredicted accidents will put the residents living in these neighborhoods at catastrophic risk."

"Emergency evacuation and issues (very concerned in the event of a major catastrophic event I would not be able to get my children as I work on opposing sides of the pipeline)."

5) Removal of trees

Removal of trees was frequently cited as a concern in the statements of opposition. A detailed route hearing looks at the specific impacts of the detailed route, methods and/or timing of construction on the land of the person filing the statement of opposition. The Board has granted detailed route hearings to some landowners bordering certain treed areas who were able to demonstrate how the tree removal would specifically impact their lands. General concerns about tree removal in local community areas do not meet this criteria (#2). Examples of these concerns include:

"The pipeline and expanded workzone will destroy an existing green belt between our property and Lougheed Highway, and the Skytrain, acting as a buffer for noise and the unsightly highway traffic."

"Removing the [tree] buffer and installing the pipeline within 10 m of properties will permanently affect not only the adjacent properties but all other properties in the neighbourhood."

"Currently our neighbourhood has one playground where the kids go to play. The proposed pipeline will remove all trees behind the park and there will be a clear path/view to tanks."

6) Interest in additional consultation and information

The Board noted that many of the concerns raised in the statements of opposition were about a lack of information being provided by Trans Mountain and thus were considered to be general in nature (#2). Several statements of opposition indicated an interest in being contacted directly by Trans Mountain. It is understandable that local residents have questions about the TMEP. The Board expects Trans Mountain to be in regular contact with communities and residents impacted by the TMEP to provide information and address questions. Examples of these concerns include:

"I am worried about the impact on the project as so far we did not receive any notifications from Kinder Morgan. The route and methods of pipeline construction and timing of the construction are all very unclear."

"I am opposed to the Kinder Morgan pipeline, tank farm and dock expansion as they did not notify me that their pipeline route would impact me directly by their construction."

"The proponent of this project, Trans Mountain Pipeline ULC has not provided a detailed plan of how it intends to protect this neighbourhood in the case of released emissions from its operations."

Other Opportunities to Participate in a Detailed Route Hearing

As outlined in Hearing Orders MH-032-2017 to MH-059-2017 issued by the Board on 4 October 2017, there will be an opportunity for persons to apply to participate in any of the detailed route hearings for Segment 7 as a Commenter or Intervenor. This can be done by filing an application to participate using the Board's Application to Participate portal **before 3:00 pm Pacific Time (4:00 pm Mountain Time) on 31 October 2017**. Complete instructions are provided in section 3 of the Hearing Order. The Board will determine who will be allowed to participate as a Commenter or Intervenor in each of the detailed route hearings.

The Board directs Trans Mountain to serve by 3:00 pm Pacific Time (4:00 pm Mountain Time) on 17 October 2017 a copy of this Letter of Decision, the Hearing Order and its appendices, and its cover letter on all persons listed in Appendix I and Appendix II attached to this Letter of Decision (being Appendix II and Appendix III of the Hearing Order).

Further notification requirements, including requirements for the publication of the Notice of Public Hearing and providing information to Aboriginal groups are noted in the Hearing Order in sections 2.6 and 2.7.
