**Review and Variance Application filed by TransCanada (Review Application)
Hearing Order MH-002-2013 – Updated Procedural Schedule**

On 12 August 2013, TransCanada PipeLines Limited (TransCanada) filed the Review Application with the National Energy Board. TransCanada requested, among other things, that the Board rescind Hearing Order MH-002-2013 and hold oral hearing that allows for cross-examination commencing on 9 December 2013.

On 13 August 2013, the Board set out a process for how it would hear the Review Application.

On 15 August 2013, Société en commandite Gaz Métro (Gaz Métro) and Union Gas Limited (Union) filed submissions on the Review Application and, on 16 August 2013, TransCanada responded to those submissions.

After considering the Review Application, and the submissions on it, the Board has decided to update the timetable of events and establish a hearing procedure that allows for cross-examination. An updated timetable of events setting out the procedural steps for the proceeding is attached as Appendix I to this letter.

The Board's reasons for its decision on the Review Application will follow.

The Board directs Union or Gaz Métro to serve a copy of this letter on the List of Parties, which is attached as Appendix II to this letter. The Board has decided to allow Nexen Energy ULC to participate in the MH-002-2013 proceeding although its submission was received after the filing deadline.
