DECISION AND ORDER

The Application and Evidence

By application dated April 6, 2004, Union Gas Limited ("Union") applied pursuant to sub-section 39(2) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Sched. B for an order approving, without a hearing, the parties to, the period of, and the storage space that are the subject of a long-term storage service contract. The Board has assigned this application File No. RP-2004-0157/EB-2004-0240.

Union proposes to assign Contract LST034 from Cargill Limited to Enbridge Gas Services Inc.. The Board approved the parties to, the period of, and the storage that were the subject of Contract LST034 by its Decision and Order dated November 10, 2003, Board File No. RP-2003-0194/EB-2003-0241. The proposed contract, Contract LST040, between Union and EGSI provides for 337,617 GJ (0.32 Bcf) of storage space from April 1, 2004 until March 31, 2007 as a peaking storage service. Other than the change of party and shortening of the period of the contract, from three years and nine months to three years, while maintaining the termination date, the terms and conditions of Contract LST040 are the same as those of Contract LST034. In order to be able to provide EGSI with the

desired services for the period April 1, 2004 until the subject application is dealt with, Union and EGSI have entered into an Enhanced Parking Service Agreement HUB305E1; this agreement satisfies the conditions of the Board's blanket storage exemption.

In its application, Union requested that the negotiated price and certain details concerning the operating parameters of Contract LST040 be held in confidence, per the Board's Rules of Practice and Procedure, on the grounds that this information is commercially sensitive and that its disclosure may harm both the customer's and Union's competitive positions. Consequently, Schedule "A" of the contract, which contains pricing information, was filed confidentially with the Board and is not publicly available.

Union provided evidence that Cargill Limited had requested, in writing, that Contract LST034 be assigned to EGSI. Execution of Contract LST040 is conditional on termination of Contract LST034, termination of Enhanced Parking Service Agreement HUB305E1 and Board approval of Contract LST040.

According to Union, granting this application will not adversely affect Union's rate payers.

Board Findings

The Board has proceeded without a hearing. The Board will grant the confidentiality requested by Union, in accordance with the Board's Rules of Practice and Procedure. The Board finds that approval of the parties to, the period of, and the storage space that are the subject of Contract LST040 and that cancellation of Contract LST034 and Enhanced Parking Service Agreement HUB305E1 are in the public interest.

THE BOARD THEREFORE ORDERS THAT:

- 1. Subject to the conditions of this Order, the Board approves:
 - 1. the parties to;
 - 2. the period of; and
 - 3. the storage space that is the subject of

Contract LST040, attached to this Order as Appendix "A".

2. Upon execution of Contract LST040, between Union Gas Limited and Enbridge Gas Services Inc., Enhanced Parking Service Agreement HUB305E1, between Union Gas Limited and Enbridge Gas Services Inc., and Contract LST034, between Union Gas Limited and Cargill Limited, are cancelled.
