PROCEDURAL ORDER NO. 2

Market Hub Partners Canada L.P. ("MHP") applied for several Board orders that would, taken together, allow MHP to provide gas storage services according to a proposed range rate (the "Application"). By letter dated November 7, 2002, MHP requested that the Board adjourn the Application due to current industry conditions. The Board granted a three month adjournment of the Application, subject to a condition that MHP communicate to the Board its intention to re-activate the Application within three months of January 30, 2003.

MHP, by letter dated April 24, 2003 requested that the Board extend the adjournment for a further 6 months to allow it to continue work on the proposed project with the intent to commence construction in 2004.

THE BOARD ORDERS THAT:

The Application RP-2002-0139/EB-2002-0415/EB-2002-0421 is adjourned until October 31, 2003. The Board expects Market Hub Partners Canada L.P. to proceed with the Application on or prior to that date, or withdraw the Application.
