

IN THE MATTER OF the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended;

AND IN THE MATTER OF an application by Union Gas Limited for an order cancelling or superseding parts of existing Certificates of Public Convenience and Necessity for certain geographic areas that now form the Municipality of Dawn-Euphemia and replacing these with a single Certificate of Public Convenience and Necessity.

DECISION AND ORDER

Union Gas Limited ("Union") has filed an application dated July 28, 2009 with the Ontario Energy Board (the "Board") under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act"), for an order of the Board that cancels or supersedes the parts of the existing Certificates of Public Convenience and Necessity associated with the former municipalities now within the Municipality of Dawn-Euphemia (the "Municipality") and establishes a single Certificate of Public Convenience and Necessity (the "Certificate") for the Municipality.

The Board assigned File No. EB-2009-0305 to this application. The Board's Notice of Application and Written Hearing was published as directed by the Board. There were no intervenors.

On January 1, 1998, the former Township of Dawn and the former Township of Euphemia were amalgamated to form the Municipality of Dawn-Euphemia by Minister's Order dated June 26, 1997. Union also holds a Certificate of Public Convenience and Necessity the former Township of Dawn (F.B.C. 192), and the former Township of Euphemia (P.F.A 5643).

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

IT IS THEREFORE ORDERED THAT:

- The parts of the existing Certificate of Public Convenience and Necessity F.B.C.
 192 covering the former Township of Dawn and the parts of the existing Certificate
 of Public Convenience and Necessity P.F.A. 5643 covering the former Township of
 Euphemia are superseded by the certificate attached as Appendix A to this Decision
 and Order.
- 2. A Certificate of Public Convenience and Necessity, attached as Appendix A to this Decision and Order, is granted to Union Gas Limited to construct works to supply gas in the Municipality of Dawn-Euphemia.
