### **DECISION AND ORDER**

Enbridge Gas Distribution Inc. ( the “Applicant”) has filed an application dated December 18, 2007, and updated on January 9, 2008 with the Ontario Energy Board (the “Board”) under section 8 of the *Municipal Franchises Act*, for an order of the Board granting a Certificate of Public Convenience and Necessity (“Certificate”) for the Township of North Stormont limited to the area formerly known as the Township of Roxborough.

The Board notes that effective January 1, 1998 the former Township of Finch, the Village of Finch, and the Township of Roxborough amalgamated to form the Township of North Stormont. Union Gas Limited has a certificate of public convenience and necessity for the former Township of Finch and for the former Village of Finch. The Board has assigned File No. EB-2007-0956 to this application.

The Board’s Notice of Application and Written Hearing was published on February 16, 2008. There were no intervenors.

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

**IT IS THEREFORE ORDERED THAT:**

1. A Certificate of Public Convenience and Necessity, attached as Appendix A to this Decision and Order, is granted to Enbridge Gas Distribution Inc. to construct works to supply gas in the Township North Stormont, limited to the area formerly known as the Township of Roxborough.
