**AND IN THE MATTER OF** an application by Union Gas Limited for an order cancelling existing Certificates of Public Convenience and Necessity for certain geographic areas that now form part of the Town of Milton and replacing these with a single Certificate of Public Convenience and Necessity.

### **DECISION AND ORDER**

Union Gas Limited ( "the Applicant") has filed an application dated April 7, 2008 with the Ontario Energy Board (the "Board") under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act"), for an order of the Board that supersedes the portion of the existing Certificate of Public Convenience and Necessity ("Certificate") associated with the former municipalities now within the Town of Milton (the "Municipality") and establishes a single Certificate of Public Convenience and Necessity for the Municipality.

The Board has assigned File No. EB-2008-0078 to this application.

The Board's Notice of Application and Written Hearing was published on April, 22, 2008. There were no intervenors.

The former municipalities that make up the Municipality include the former Town of Milton, the former Township of Trafalgar, a portion of the former Township of Esquesing and a portion of the former Township of Nassagaweya. The Applicant holds a Certificate (F.B.C. 324) which covers the first three of the above areas as well as other

areas outside of the Municipality. No Certificate is held for the portion of the former Township of Nassagaweya now within the Municipality.

There are no gas utilities, other than Union Gas Limited, within the Municipality.

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

**IT IS THEREFORE ORDERED THAT:**

1. The portions of the existing Certificate of Public Convenience and Necessity F.B.C. 324 covering the former Town of Milton, the former Township of Trafalgar and a portion of the former Township of Esquesing are superseded by the certificate attached as Appendix A to this Decision and Order.
2. A Certificate of Public Convenience and Necessity, attached as Appendix A to this Decision and Order, is granted to Union Gas Limited to construct works to supply gas in the Town of Milton.
