ORDER FOLLOWING THE CASE MANAGEMENT TELECONFERENCE HELD ON APRIL 21, 2006

- [iv] Service of affidavits of expert witnesses: Saturday, September 2, 2006
- [v] Service of affidavits of rebuttal: Friday, September 15, 2006
- [vi] Filing of affidavits of expert witnesses: Friday, September 22, 2006
- [vii] Service of notice indicating names and addresses of witnesses: Monday, September 25, 2006
- [viii] Disclosure of the list of admissible documents under section 69 of the Act: Monday, September 25, 2006
- [6] A case management teleconference will take place between June 26 and June 30, 2006. The date and time for this teleconference remains to be confirmed.
- [7] Ten days are scheduled for the hearing of the application, which will be held in Montréal, Quebec, from Monday, October 2, 2006, to Friday, October 6, 2006, and from Monday, October 16, 2006, to Friday, October 20, 2006.
