Date: February 25, 2025**Proposed Matter:** CT-2024-002 – *Winston Gaskin et al. v Rogers Communications Inc. et al.***Direction to Mr Gaskin (from Justice Little, Chairperson)**

The Tribunal understands that since the issuance of its Direction dated February 4, 2025, you have created an e-Filing Profile by registering with the Tribunal's E-Filing Depot, which allows registrants to securely submit and retrieve documents related to a Tribunal matter. Unfortunately, it appears that it was not used in your most recent attempt to submit documents, and that instead you continued to send emails with attachments to the Registry. As indicated previously, this is not an acceptable way to file documents with the Registry.

On February 13, 2025, you sent an email to the Registry attaching a "working copy" of an 89-page letter dated January 19, 2025, addressed to the Ontario Securities Commission, the Competition Bureau and the Competition Tribunal. The same email attempts to send various other documents using GoogleDrive. None of these documents were sent using the Tribunal's e-Filing Depot.

In addition, the 89-page letter was not a proper informal motion or informal request for directions from the Tribunal (*ex parte* or otherwise). The Tribunal does not understand what is requested by way of directions, and many of the allegations and statements found in it do not pertain to matters within the Tribunal's jurisdiction.

Finally, it also appears that there has been no attempt to serve any proposed originating documents on any proposed respondents since the Tribunal's Direction, Order and Reasons dated April 15, 2024.

The Tribunal directs as follows:

1. The Tribunal's e-Filing Depot is the only channel that may be used to file documents with the Registry. Until otherwise notified, the Registry is directed not to accept any documents or emails in the present matter for proposed filing unless they are sent through the e-Filing Depot.

The Registry will assist if you have questions that cannot be answered by reading the information about filing procedures on the Tribunal's website, or if you experience difficulties using the e-Filing Depot.

2. If you wish to file an application with the Tribunal, you must ensure that it is a type that can be heard by the Tribunal, considering its jurisdiction; in other words, an application must be restricted to legal and factual matters that the Tribunal can hear and determine.
3. Please re-read the Direction, Order and Reasons dated April 15, 2024, and paragraph 3 of the Direction dated February 4, 2025.
4. Compliance with the requirements for personal service of originating documents on proposed respondents is required.
5. Compliance with the *Competition Tribunal Rules* is also required.

The Tribunal will not take any other action at this time in response to the letter dated January 19, 2025.
