NOTICE OF HEARING

TAKE NOTICE that The Manitoba Securities Commission ("Commission") will hold a public hearing ("Hearing") at its offices at Room 500 - 400 St. Mary Avenue, Winnipeg, Manitoba on Wednesday, the 1st day of June, 2011 commencing at 9:00 o'clock in the forenoon or so soon thereafter as the Hearing can be held, and from day to day thereafter until the Hearing is concluded, to consider pursuant to section 148.4 of *The Securities Act*, R.S.M. 1988, c. S50 as amended ("Act"):

- whether or not it is in the public interest to order, pursuant to section 148 of Act, that all trading in securities of 1205676 Alberta Ltd. operating as "Front Row Tickets" ("FRONT ROW") cease;
- whether or not it is in the public interest to order, pursuant to section 148 of Act, that all trading in securities by FRONT ROW, 660648 Alberta Ltd. operating as "S & I Holdings" and "S & I Holdings (Ticket Today)" (collectively referred to as "S & I"), Windy Ridge Investments Ltd. ("WINDY RIDGE"), Jason Allan Hunt ("HUNT"), Anthony Pittarelli ("PITTARELLI"), Giovanna Campanelli-Pittarelli ("CAMPANELLI-PITTARELLI"), Sam Sakai

Tamura ("TAMURA"), Robert Claire Pilling ("PILLING"), Daniel Neil McLeod ("McLEOD"), Jimmy Ross Creason ("JIMMY CREASON"), and/or Jamie Craig Creason ("JAMIE CREASON") cease:

- 3. whether or not it is in the public interest to order, pursuant to section 19(5) of the Act, that:
 - (a) subsection 19(1) of the Act does not, with respect to such of the trades referred to in that section, apply to FRONT ROW, S & I, WINDY RIDGE, HUNT, PITTARELLI, CAMPANELLI-PITTARELLI,TAMURA,PILLING, McLEOD, JIMMY CREASON, and/or JAMIE CREASON;
 - (b) subsection 19(2) of the Act does not, with respect to such of the securities referred to in that section, apply to FRONT ROW, S & I, WINDY RIDGE, HUNT, PITTARELLI, CAMPANELLI-PITTARELLI, TAMURA, PILLING, McLEOD, JIMMY CREASON, and/or JAMIE CREASON;
- 4. whether or not it is in the public interest to order, pursuant to section 148.3 of the Act, that HUNT and/or PITTARELLI resign all positions they/he hold(s) as a director or officer of any issuer and be prohibited from becoming or acting as a director or officer or both of any issuer;
- 5. such further and other matters and the making of such further and other orders as the Commission may deem appropriate.

BY REASON OF THE FOLLOWING ALLEGATIONS:

By reason of a Decision of the Alberta Securities Commission ("ASC") dated November 23, 2010, to be filed, and such other material as staff counsel may advise and the panel may allow.

AND FURTHER TAKE NOTICE that a person or company attending or submitting evidence at the Hearing may be represented by counsel of its choice.

AND FURTHER TAKE NOTICE that any party to the proceedings may, at the Hearing, call witnesses and submit such evidence relevant to the Hearing as it may wish and, for that purpose, it may obtain from the Director of the Commission at Room 500 – 400 St. Mary Avenue, Winnipeg, Manitoba, a form or forms of summons to compel the attendance of witnesses.

AND FURTHER TAKE NOTICE that upon failure of any party to attend at the time and place aforesaid, the Hearing may proceed in that party's absence and the Commission may make or give any decision or order as though that party were present.
