

THE SECURITIES ACT Sections 148 and 19(5))	Order No. 6534

SULJA BROS. BUILDING SUPPLIES, LTD.

WHEREAS:

- (A) On June 29, 2011, the Ontario Securities Commission ("OSC") issued an Order against the respondent ("OSC Order");
- **(B)** On December 1, 2011, The Manitoba Securities Commission ("Commission") issued a Notice of Hearing ("Notice") giving notice of its intention to hold a hearing to consider whether or not it was in the public interest to grant orders pursuant to *The Securities Act*, R.S.M. 1988, c. S50 as amended ("Act") with respect to various respondents including SULJA BROS. BUILDING SUPPLIES, LTD.;
- (C) This hearing matter came before a panel of the Commission on February 15, 2012, April 25, 2012 and May 30, 2012;
- (D) Upon reviewing the documentary evidence including the Affidavit of Service and hearing the submissions of counsel for staff of the Commission, no one appearing for the respondent, and upon being satisfied as to service upon the respondent, the Commission is of the opinion that it is in the public interest to make this order.

IT IS ORDERED:

- 1. THAT, pursuant to section 148 of the Act, SULJA BROS. BUILDING SUPPLIES, LTD. cease trading in securities permanently.
- **2. THAT**, pursuant to subsection 19(5) of the Act, subsection 19(1) of the Act, with respect to such of the trades referred to in that subsection, and subsection 19(2) of the Act, with respect to such of the securities referred to in that subsection, do not apply to SULJA BROS. BUILDING SUPPLIES, LTD. permanently.
