WHEREAS:

- (A) Source Life Sciences Inc. (the "Issuer") is subject to the requirements of Part XII of The Securities Act (Manitoba) (the "Act") and National Instrument 51-102 Continuous Disclosure Obligations ("NI 51-102");
- **(B)** The Issuer has a financial year end of October 31st;
- (C) The Issuer has failed to file with The Manitoba Securities Commission (the "Commission") a copy of its Annual financial statements for the year ended October 31, 2005 as required by NI 51-102 (the "Financial Statements");
- (**D**) On the basis of the foregoing, I am of the opinion that it is in the public interest that trading in the securities of the Issuer should cease forthwith for a period of fifteen days and I am further of the opinion that the holding of a hearing would cause a delay which would be prejudicial to the public interest.

I HEREBY ORDER under a delegation to me by the Commission under subsection 4(1) of the Act of the powers in that behalf:

- **1. THAT**, under section 148(1) of the Act, trading in the securities of the Issuer shall cease forthwith for a period of fifteen days from March 13, 2006 to March 27, 2006, both dates inclusive, or until such earlier date as:
 - (a) the Issuer files a copy of the Financial Statements and pays all outstanding filing fees to the Commission; and
 - (b) the Issuer submits a written request to the Commission to have this order revoked.
