REVOCATION OF CERTAIN REGISTRATION-RELATED BLANKET / OMNIBUS ORDERS

Interpretation

Unless otherwise defined in this decision or the context otherwise requires, terms used in this decision that are defined in NI 31-103 or National Instrument 14-101 *Definitions* have the same meaning.

WHEREAS

1. As a result of amendments to National Instrument 31-103 *Registration Requirements, Exemptions and Ongoing Registrant Obligations* (NI 31-103), which came into force on July 11, 2011, the subject matter or substantive effect of each of the following blanket orders is now subsumed in NI 31-103:

- (a) Blanket Order 31-507 *Exemption from Sections 3.6, 3.10 and 3.14 of National Instrument 31-103 Registration Requirements and Exemptions for Chief Compliance Officers of Portfolio Managers Adding a Category*;
- (b) Blanket Order 31-508 *Exemption from Sections 3.5 and 3.9 of National Instrument 31-103 Registration Requirements and Exemptions for Portfolio Managers Adding a Category*;
- (c) Blanket Order 31-510 *Exemption from Section 14.5 of National Instrument 31-103 Registration Requirements and Exemptions for Canadian Firms*;
- (d) Blanket Order 31-511 *Exemption from Requirement to Establish Whether a Client is an Insider (Section 13.2(2)(b) of NI 31-103)*; and
- (e) Blanket Order 31-513 *Exemption from the Requirement that Mutual Fund Dealers Identify Individuals with 10% Interests in Corporate Clients (Section 13.2(3)(b)(i) of NI 31-103)*.

(collectively, the "Blanket Orders")



The Commission is of the opinion that it would not be prejudicial to the public interest to make the order requested.

IT IS ORDERED:

1. THAT under s. 20(1) of *The Securities Act*, R.S.M. 1988, s. 50, the Blanket Orders are revoked effective September 16, 2011
