# Notice of Amendments to Fee Regulation under *The Securities Act*

#### Manitoba Regulation 1(2)(q.7) & (q.8)

The Government of Manitoba, through Cabinet, has approved amendments to the fee Regulation under *The Securities Act* (the "Act") which have been enacted effective October 3, 2018.

The amendments have added a fee of \$1,150 to the International Dealer Exemption under Section 8.18 of Rule 31-103 and the International Adviser Exemption under Section 8.26 of Rule 31-103 under the Act for registration matters. If the firm is filing under both exemptions concurrently, the fee is \$1,150.

The fee collection will be required upon filing an initial Form 31-103F2 Submission to Jurisdiction and Appointment of Agent for Service and upon filing of an annual notice for continued reliance.

So long as the firm continues to rely on the exemption, it must file an annual notice with The Manitoba Securities Commission under Subsection 8.26(5) and/or Subsection 8.18(5) by email or letter. A cheque in the amount of \$1,150 in Canadian funds made payable to The Minister of Finance is required by December 1<sup>st</sup> of each year.

A listing summarizing the applicable fee changes is attached to this Notice.
