- [1] On October 29, 2012, this matter came before me for a hearing after the Defendant had been noted in default.
- [2] Briefly, the facts are that the Plaintiff attended the Defendant's property, North Country Stables, to purchase a second load of horse manure; the Plaintiff had been to the property the previous day to purchase horse manure.
- [3] While on the Defendant's property, the Plaintiff was bit by the Defendant's Great Dane dog.
- [4] As a result of being bitten, the Plaintiff was in pain for at least 10 days, the pain being severe for five days; the Plaintiff was on antibiotics for 10 days; the Plaintiff was unable to pursue her normal activities for at least five days; and the Plaintiff has permanent scarring on her arm from the bite. While on antibiotics the Plaintiff also had to make some adjustments to her diet requiring the purchase of some special foods which she estimated cost her approximately \$75.00.

[5] I accept the Plaintiff's testimony that she suffered severe pain for five days due to

the dog bite, and that she was not able to pursue her usual activities during that five day

period. I find the Plaintiff's claim for financial compensation of \$200.00 per day for this five

day period to be eminently reasonable.

[6] The Plaintiff further seeks \$560.00 to have a load of manure delivered to her home.

The Plaintiff had attended the Defendant's property to purchase a load of manure, but had

not pre-paid for the manure. The Plaintiff did not lose a load of manure due to the

Defendant's dog biting her. I accept that she attended the Defendant's property on the

morning of June 7, 2012, and ended up spending most of that day in emergency after she

was bitten, and to the extent that she lost a day, she will be compensated for a further day

beyond the five days of pain and suffering, but the claim to be compensated for a delivered

load of manure is not allowed.

[7] The Plaintiff's application for default judgment is granted in the amount of \$200.00

per day for six days, \$75.00 for the cost of special foods, disbursements of 128.75, and

costs allowed on default judgment of \$100.00; total judgment for the Plaintiff in the amount

of \$1,503.75.
