**ORDER AMENDING CERTIFICATION**

On June 30, 2008, City Employees Union, Local 237, IBT (“Local 237”) filed a petition pursuant to § 1-02(u) of the Rules of the Office of Collective Bargaining (Rules of the City of New York, Title 61, Chapter 1) requesting that the Board of Certification amend Certification No. 14-80, a bargaining unit that includes Baker, Commissary Manager, Superintendent of Laundries, and other institutional titles, to reflect that Local 237 is the sole certificate holder following the merger of joint

certificate holders Local 237 and Terminal Employees Union, Local 832, IBT.<sup>1</sup>

Notice of this petition was given to the City of New York, the New York City Health and Hospitals Corporation, and the public. No objections were filed. Accordingly, we amend the certification to reflect the merger. *See 144 Division of 1199 Nat'l Health and Human Serv. Employees Union, SEIU, 62 OCB 9 (BOC 1998) (amending certification to reflect certificate holder's merger with another union).*

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

ORDERED that Certification No. 14-80 (as previously amended) be, and the same hereby is, further amended to provide that City Employees Union, Local 237, IBT is the sole certified bargaining representative.
