ORDER AMENDING CERTIFICATION

The parties hereto having agreed, and it appearing to the satisfaction of the Board, that the titles of Group Homemaker, Addiction Counselor, Assistant Addiction Counselor and Program Specialist (Correction) should be added, by accretion, to Certification No.11-72, as previously amended by Decisions 17-72, 20-72 and 21-72, presently covering various non-supervisory social service and related titles, the cited Certification being held by the Union;

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

ORDERED, that Certification No.11-72, as previously amended by Decisions 17-72, 20-72 and 21-72, be, and the same hereby is, further amended to include the titles of Group Homemaker, Addiction Counselor, Assistant Addiction Counselor and Program Specialist (Correction), and as amended, such unit shall be cited as "Decision No.26-72" and shall consist of Addiction Aide, Addiction Counselor, Addiction Specialist (including specialty), Area Services Coordinator,

Assistant Addiction Counselor, Assistant Area Services Coordinator, Assistant Case Worker, Assistant Community Liaison Worker, Assistant Community Organization Specialist (Urban Renewal), Assistant Community Specialist (Model Cities), Assistant Teacher (Day Care Center), Case Aide, Case Worker, Children's Counselor, Community Aide (Model Cities), Community Liaison Aide, Community Liaison Trainee, Community Organization Specialist (Urban Renewal), Community Service Aide, Community Trainee (Model Cities), Correctional Aide, Correctional Counselor, Counselor (Addiction Treatment), Drug Abuse Aide (E.E.A.), Drug Abuse Aide (E.E.A.-6), Drug Abuse Aide (E.E.A.-W), Drug Abuse Specialist (E.E.A.), Drug Abuse Specialist (E.E.A.-6), Group Homemaker, Home Economist, Home Economist Trainee, Hospital Care Investigator, House Parent, Human Resources Aide, Human Resources Specialist (including specialty), Human Resources Specialist Trainee, Human Resources Technician (including specialty), Program Coordinator (Model Cities), Program Specialist (Correction), Program Specialist (Model Cities), Research Assistant (Behavioral Sciences), Senior Citizen Aide (Office for the Aging), Senior Citizen Specialist I (Office for the Aging), Senior Citizen Specialist II (Office for the Aging), Senior House Parent, Senior Human Resources Specialist (including specialty), Senior Human Resources Technician (including specialty), Senior Program Coordinator (Model Cities), , Senior Program
