the exclusive representative for the purposes of collective bar- gaining of all employees in the consolidated unit, to wit: Com-

pliance Specialist (EEA), Compliance Specialist (EEA-6), Inves-

tigator (EEA), Investigator (EEA-6), Decedent Property Agent, Investigator Aide, Investigator, Senior Investigator, Supervising Investigator, and employees in restored Rule X titles equated to the foregoing titles, employed by the City of New York and

related public employers subject to the jurisdiction of the

Board of Certification, and, further, subject to existing con- tracts, if any, covering any or all of said employees.
