CERTIFIED, that District Council 37, AFSCME, AFL-CIO, and/or its affiliated locals, is the exclusive representative for the purposes of collective bargaining of all employees in the consolidated unit, to wit: Junior Public Health Nurse [full time], Public Health Nurse, Public Health Nurse (Session), Pediatric Nurse Associate, Supervising Public Health Nurse, District Supervising Public Health Nurse, and Consultant Public Health Nurse (including all specialties), employed by the City of New York and related public employers, subject to the juris- diction of the Board of Certification, and, further, subject to existing contracts, if any, covering any or all of said employees.
