DECISION AND ORDER

ORDERED, that Certifications CWR-58/67 and CWR-59/67 (as amended by Decisions 51-69 and 26-70) be, and the same hereby are, combined and consolidated so as to constitute one bargaining unit consisting of the titles set forth below; and it is hereby

CERTIFIED, that District Council 37, AFSCME, AFL-CIO, and/or its affiliated locals, is the exclusive representative for the purposes of collective bargaining of all employees in the consolidated unit, to wit: Assistant Rent Examiner, Rent Examiner, Rent Inspector, Senior Rent Examiner, Supervising Rent Examiner, Principal Rent Examiner, Senior Rent Inspector, and Supervising Rent Inspector, employed by the City of New York and related public employers, subject to the jurisdiction of the Board of Certification, and, further, subject to existing contracts, if any, covering any or all of said employees.
