DECISION AND ORDER CONSOLIDATING
CERTIFICATIONS

On November 9, 1973, the Office of Labor Relations of the City of New York filed its motion herein, requesting the consolidation of the following certifications:
Certification

No.10-71, held by Civil Service Forum, Local 300, SEIU, AFL-CIO, and covering Fingerprint Technician Trainee, Fingerprint Technician, Senior Fingerprint Technician, Principal Fingerprint Technician, and restored Rule X equivalent; and Certification No.33-73, held by Local 1070, District

Council 37, AFSCME, AFL-CIO, and covering Identification Officer, Senior Identification Officer, and Principal Identification Officer. The parties have been notified of the pendency of this motion, and no valid objection has been raised.

_____ Our investigation shows that such a consolidated unit would be appropriate for collective bargaining purposes and that a majority of the employees in the combined unit have authorized dues check-off in behalf of Local 300.

ORDER

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

ORDERED that Certifications 10-71 and 33-73 be, and the same hereby are, combined and consolidated so as to constitute one bargaining unit consisting of the titles set forth below; and it is hereby

CERTIFIED that Civil Service Forum, Local 300, SEIU, ALF-CIO, is the exclusive representative for the purposes of collective bargaining of all employees in the consolidated unit, to wit: Identification Officers, Senior Identification Officers, Principal Identification Officers, Fingerprint Technician Trainees, Fingerprint Technicians, Senior Fingerprint Technicians, Principal Fingerprint Technicians, and employees in restored Rule X titles serving in positions equated thereto, employed by the City of New York and related public employers subject to the jurisdiction of the
