CERTIFIED that District Council 37, AFSCME, AFL-CIO, is the exclusive representative for the purposes of collective bargaining of all employees in the consolidated unit, to wit: Dental Hygienist, Dental Assistant, Supervising Dental Assistant, Public Health Assistant, Assistant Public Health Adviser (Communicable Disease Control), Public Health Adviser (Communicable Disease Control), Senior Public Health Adviser (Communicable Disease Control), Assistant Venereal Disease Decision No. 60-74 Docket No. RB-51-74

Case Finder (EEA), Assistant Venereal Disease Case Finder (EEA-6), Assistant Venereal Disease Case Finder (EEA-W), and Venereal Disease Case Finder (EEA), employed by the City of New York and related public employers subject to the jurisdiction of the Board of Certification, and, further, subject to existing contracts, if any, covering any or all of said employees.
