NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

ORDERED that Certification No. 39-73, as previously amended by Decision No. 51-73, be, and the same hereby is, further amended to include the titles of Fiscal Office Assistant (CETA), Office Assistant (CETA) and Secretary (CETA); and it is further

ORDERED that Certification No. 22-72, as previously amended by Decisions 58-72 and 57-73, be, and the same hereby is further amended to include the titles of Patient Aide (CETA) and Hospital Aide (CETA), subject to existing contracts, if any.
