CERTIFICATION OF REPRESENTATIVE

Writers, Script Writers, Television Directors, Assistant Program Managers, Program Managers, Broadcast Traffic Assistants, Audience Promotion Assistants, Assistant Musical Supervisors, Musical Supervisors, Announcers, Senior Announcers, and employees in restored Rule X titles serving in positions equated thereto, have voted in favor of representation by Municipal Guild of Radio and Television Technicians; and no objections having been filed within the time Provided therefor;

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

CERTIFIED that Municipal Guild of Radio and Television Technicians is the exclusive representative for the purposes of collective bargaining of all Radio Operators, Senior Radio Operators, Supervisors of Radio Operation, Supervisors of Television Operations, Chief Supervisors of Radio Operation, Chief Supervisors of Television Operations, Television Lighting Technicians, Assistant Television Cameramen, Television Cameramen, Film Editors, Film Managers, Production Coordinators (Television), Program Production Assistants (including specialties), Continuity Writers, Script Writes, Television Directors, Assistant Program Managers, Program Managers, Broadcast Traffic Assistants, Audience Promotion Assistants, Assistant Musical Supervisors, Musical Supervisors, Announcers, Senior Announcers, and employees in restored Rule X titles serving
