**ORDER AMENDING CERTIFICATION**

On August 14, 2009, 1199 SEIU United Healthcare Workers East (“Union”) filed a motion requesting that the Board amend Certification No. CWR 23/67, a bargaining unit that includes titles such as Laboratory Microbiologist, to reflect that the certificate holder has changed its name from 144 Division of 1199 National Health and Human Services Employees Union/SEIU to 1199 SEIU United Healthcare Workers East.

ORDERED that Certification No. CWR 23/67 (as previously amended) be, and the same hereby is, further amended to reflect that the certificate holder has changed its name to 1199 SEIU United Healthcare Workers East.
