DECERTIFICATION ORDER

An election having been conducted in the above matter on June 2, 1978, pursuant to the Direction of Election herein (Decision No. 8-78), and it appearing from the Report Upon Secret Ballot that a majority of the Electrical Inspectors, Senior Electrical Inspectors, Supervising Electrical Inspectors, Principal Electrical Inspectors, Inspectors of Fire Alarm Boxes, Senior Inspectors of Fire Alarm Boxes, Fire Alarm Dispatchers,<sup>1</sup> and Supervising Fire Alarm Dispatchers, casting valid ballots in said election have voted against representation by Local union No. 3, International Brotherhood of Electrical Workers, AFL-CIO; and no objections having been filed within the time provided therefor;

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

Although the cited Direction of Election also included "employees in restored Rule X titles serving in positions equated thereto," there are no longer any such employees in this unit.

ORDERED that Local Union No. 3, International Brotherhood of Electrical Workers, AFL-CIO, be, and it hereby is, DECERTIFIED as the exclusive representative for the purposes of collective bargaining of the Electrical Inspectors, Senior Electrical Inspectors, Supervising Electrical Inspectors, Principal Electrical Inspectors, Inspectors of Fire Alarm Boxes, Senior Inspectors of Fire Alarm Boxes, Fire Alarm Dispatchers, and Supervising Fire Alarm Dispatchers, employed by the City of New York and related public employers subject to the jurisdiction of the Board of Certification.
