The City's Office of Municipal Labor Relations states that it has no objection to this petition, and we find that such a consolidation would constitute a residual unit which would be appropriate for collective bargaining purposes.

O R D E R

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

ORDERED that Certification No. 58A-76 and Certification No. 20-78 (as amended) be, and the same hereby are, combined and consolidated so as to constitute one bargaining unit (to be cited by the present Decision Number), consisting of the titles set forth in the Appendix to this order; and it is hereby

CERTIFIED that Local 300, the Civil Service Forum, S.E.I.U. AFL-CIO, is the exclusive representative for the Purposes of collective bargaining of all employees in the consolidated unit, subject to existing contracts, if any.
