CERTIFICATION OF REPRESENTATIVE

An election having been conducted in the above matter on May 21, 1980, pursuant to the Direction of Election herein (Decision No. 6-80), and it appearing from the Report Upon Secret Ballot that a majority of the Registered Professional Nurses (CETA), Staff Nurses, Nurse Midwives, Nurse Practitioners, Assistant Head Nurses, Head Nurses, and Supervisors of Nurses casting valid ballots in the election, voted in favor of representation by New York State Nurses Association; and no objections having been filed within the time provided therefor;

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

CERTIFIED that New York State Nurses Association is the exclusive representative for the purposes of collective bargaining of all Registered Professional Nurses (CETA),<sup>1</sup> Staff Nurses,<sup>2</sup> Nurse-Midwives, Nurse Practitioners, Assistant Head Nurses, Head Nurses, and Supervisors of Nurses, employed by the City of New York and related public employers subject to the jurisdiction of the Board of Certification, subject to existing contracts, if any.
