ORDERED that Certification No. 38B-78 (as amended by Decisions 1-80 and 10-80) be, and the same hereby is, further amended by deleting therefrom the titles of Life Guard, Seasonal Filtration Plant Operator, Seasonal Park Helper, Seasonal Parkman, and Playground Assistant; and it is

Certification No. 38A-78 covers a supervisory custodial, maintenance and related unit, consisting of 36 titles; and Certification No. 38B-78 (as amended by Decisions 1-80 and 10-80) covers the non-supervisory counterpart unit, consisting of 42 titles. Both of the cited Certifications are held by District Council 37.

CERTIFIED that District Council 37, AFSCME, AFL-CIO is the exclusive representative for the purposes of collective bargaining of all City Seasonal Aides, Life Guards, Chief Life Guards, Playground Assistants, Seasonal Filtration Plant Operators, * Seasonal Park Helpers, * and Seasonal Parkmen* employed by the City of New York and related public employers subject to the jurisdiction of the Office of Collective Bargaining, subject to existing contracts, if any.
