**ORDER AMENDING CERTIFICATION**

On March 16, 2010, the New York City Health and Hospitals Corporation ("HHC") filed a petition to amend Certification No. 46D-75, a bargaining unit represented by District Council 37, AFSCME, AFL-CIO ("Union"), to delete the title Associate Bookkeeper (Title Code No. 405270) to reflect the reclassification of the title to Bookkeeper Level III (Title Code No. 405270).<sup>1</sup>

Notice of this petition was given to the public and the Union. On April 2, 2010, the Union objected on the grounds that employees remained in the Associate Bookkeeper title. Our investigation shows that there are no employees currently serving in the Associate Bookkeeper title.

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law (New York City Administrative Code, Title 12, Chapter 3), it is hereby

ORDERED that Certification No. 46D-75 (as previously amended) be, and the same hereby is, further amended to delete the title Associate Bookkeeper (Title Code No. 405270).
