**ORDER AMENDING CERTIFICATION**

On September 17, 2012, the Organization of Staff Analysts (“Union”) filed a petition pursuant to § 1-02(u) of the Rules of the Office of Collective Bargaining (Rules of the City of New York, Title 61, Chapter 1) requesting that the title Training and Development Representative (Title Code No. 00463C) be accreted to Certification No. 3-88. On October 16, 2012, the Union filed a petition to add the title Supervising Training and Development Associate (Title Code No. 00464H).

Notice of these petitions was given to the public and the New York City Health and Hospitals Corporation, and no objections were filed. The Board of Certification is satisfied that no evidence was presented to rebut the Union’s assertion that Training and

Development Representatives and Supervising Training and Development Associates have a sufficient community of interest with the members of its bargaining unit.

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law (New York City Administrative Code, Title 12, Chapter 3), it is hereby

ORDERED that Certification No. 3-88 (as previously amended) be, and the same hereby is, further amended to add the titles Training and Development Representative (Title Code No. 00463C) and Supervising Training and Development Associate (Title Code No. 00464H), subject to existing contracts, if any.
