DECISION, ORDER AND AMENDED CERTIFICATION

On January 3, 1970, Civil Service Forum, Local 300, S.E.I.U., as intervener, filed a motion for reconsideration of the Decision and Certification heretofore issued herein to Association of Building Inspectors (Decision No. 1-70). The motion seeks to exclude from said certification the title of "Senior Pipe-Laying Inspector."

Oral argument on the motion was heard by the Board on March 11, 1970. Association of Building Inspectors did not appear at the oral argument but previously had advised the Board, by letter, that it had no objection to the exclusion of Senior Pipe-Laying Inspectors, as requested by Local 300.

Upon consideration of the motion papers, the letter from the Association of Building Inspectors, and the oral argument, the Board issues the following Order and Amended Certification:
