ORDER AMENDING CERTIFICATION

Upon investigation, the Board is satisfied that the titles of Assistant Purchasing Agent and Purchasing Agent - Levels I, II and III covered by Certification No. 8-85 (as amended), were consolidated into the titles of Procurement Analyst- Levels I, II and III effective January 21, 2001.

ORDERED that Certification No. 8-85 (as previously amended) be, and the same hereby is, further amended to delete the titles Assistant Purchasing Agent (Code 963400) and Purchasing Agent - Levels I, II and III (Codes 963510, 963520 and 963530) and add the title(s) of Procurement Analyst- Levels I, II and III (Codes 963510, 963520 and 963530), subject to existing contracts, if any.
