ORDER AMENDING CERTIFICATION

On August 27, 2003, District Council 37, AFSCME, AFL-CIO, ("DC 37"), filed a petition pursuant to § 1-02(v) of the Rules of the Office of Collective Bargaining (Rules of the City of New York, Title 61, Chapter 1), requesting that the title Supervisor of Investigators (CCRB)<sup>1</sup> (Title Code 06571) be accreted to its Certification No. 37-78, a bargaining unit represented by DC 37, which includes such titles as: Investigator (CCRB), Associate Fraud Investigator, Associate Personnel Investigator, and Associate Investigator. Notice of this petition was given to the public.

The City raised no objection to the inclusion of employees in the Supervisor of Investigators (CCRB) title in DC 37's bargaining unit pursuant to Certification No. 37-78. The Board of Certification is satisfied that no evidence was presented to rebut Petitioner's assertion that the title – Supervisor of Investigators (CCRB) – has a sufficient community of interest with

ORDERED that Certification No. 37-78 (as previously amended) be, and the same hereby is, further amended to add the title: Supervisor of Investigators (CCRB) (Title Code 06571), subject to existing contracts, if any.
