ORDERED, that Supervising Demolition Inspectors be and shall remain in the separate unit covered by Certification 9 NYCDL No.28 held by Local 1219, District Council 37, AFSCME, AFL-CIO; and it is

CERTIFIED, that Real Estate Local 1219, District Council 37, AFSCME, AFL-CIO, is the exclusive representative for the purposes of collective bargaining of all Demolition Inspectors, Senior Demolition Inspectors, and restored Rule X employees serving in positions equated thereto, employed

by the City of New York and related public employers subject to the jurisdiction of the Board of Certification, subject to existing contracts, if any.
