ORDER AMENDING CERTIFICATION

The parties having agreed, and it appearing to the satisfaction of the Board, that the unit appropriate for collective bargaining consists of: Assistant Teacher (Day Care Center) and Teacher Aide (Day Care Center), together with the non-supervisory social service and related titles presently covered by Unit I of Certification No. 40-71;

And it further appearing to the satisfaction of the Board that a majority of employees in said unit have demonstrated their desire to be represented by District Council 37, AFSCME, AFL-CIO, and its affiliated locals, by having authorized check-off of dues in behalf of said organization;

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law, it is hereby

ORDERED, that Unit I of Certification No. 40-71 be, and the same hereby is amended to include the titles of Assistant Teacher (Day Care Center) and Teacher Aide (Day Care Center); and, as amended, such unit shall be cited as "Decision No. 48-71" and shall consist of Teacher Aides (Day Care Center), Assistant Teachers (Day Care Center),

Assistant Community Organization Specialists (Urban Renewal), Community Organization Specialists (Urban Renewal), Assistant Area Services Coordinators, Area Services Coordinators, House Parents, Senior House Parents, Community Aides (Model Cities), Community Liaison Aides, Community Service Aides, Community Trainees (Model Cities), Assistant Community Specialists (Model Cities), Program Specialists (Model Cities), Senior Program Specialists (Model Cities), Senior Citizen Aides (Office for the Aging), Senior Citizen Specialists I (Office for the Aging), Senior Citizen Specialists II (Office for the Aging), Addiction Aides, Addiction Specialists, Community Liaison Trainees, Assistant Community Liaison Workers, Case Aides, Assistant Case Workers, Case Workers, Children's Counselors, Hospital Care Investigators, Home Economist Trainees, Home Economists, Human Resources Aides, Human Resources Technicians (including specialty), Senior Human Resources Technicians (including specialty), Human Resources Specialist Trainees, Human Resources Specialists (including specialty), Senior Human Resources Specialists (including specialty), Research Assistants (Behavioral Sciences), and employees in restored Rule X titles who are serving in positions equated thereto, employed by the City of New York and related public employers subject to the jurisdiction of the Board of Certification.
