Pursuant to the Decision and Direction of Election in *United Fed'n of Teachers*, Decision No. 12-2007, an election was held by mail ballot in this matter in accordance with § 1-02 of the Rules of the Office of Collective Bargaining (Rules of the City of New York, Title 61, Chapter 1) ("OCB Rules") for employees in the title Hearing Officer (Per Session) (Title Code No. 95937).
