Summary of Decision: CWA filed a petition to accrete the title Coordinating Manager (DOHMH). The City argued that the position of Administrative Assistant to the Deputy Commissioner was confidential, and the Union did not oppose that designation. The Board amended the Union's certification to add the Coordinating Manager (DOHMH) title with the exception of one position, which was designated as confidential. **(Official decision follows.)**

ORDER AMENDING CERTIFICATION

On February 2, 2007, Communications Workers of America, Local 1180 ("Union") filed a petition to amend its Certification No. 41-73 to include the title Coordinating Manager (DOHMH) (Title Code No. 95948), employed at the Department of Health and Mental Hygiene.¹ The City of New York ("City") does not object to the accretion of the title with the exception of the

Administrative Assistant to the Deputy Commissioner position, which it contends is confidential.

The Union does not oppose the designation of the Administrative Assistant to the Deputy

Commissioner position, currently held by Marybel Hernandez, as confidential.

The Board of Certification is satisfied that no evidence was presented to rebut the assertion that employees in the Coordinating Manager (DOHMH) title have a sufficient community of interest with members of the certified bargaining unit. As the parties have agreed to the confidential designation of the Administrative Assistant to the Deputy Commissioner position, we shall designate the position accordingly.

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law (New York City Administrative Code, Title 12, Chapter 3), it is hereby

ORDERED that employees in the title Coordinating Manager (DOHMH) (Title Code No. 95948) are eligible for collective bargaining with the exception of the Administrative Assistant to the Deputy Commissioner position, currently held by Marybel Hernandez, which is designated confidential; and it is further

ORDERED that Certification No. 41-73 (as previously amended) be, and the same hereby is, further amended to include the title Coordinating Manager (DOHMH) (Title Code No. 95948), subject to existing contracts, if any.
