**ORDER AMENDING CERTIFICATION**

30109), Senior Attorney (Title Code No. 30125), Senior Attorney (Taxes) (Title Code No. 30093), and Student Legal Assistant (Sanitation) (Title Code No. 06044).

Notice of this petition was given to the Civil Service Bar Association, International Brotherhood of Teamsters, Local 237, and the public, and no objections were filed. The Board of Certification is satisfied that there are no incumbents in the titles and that the City does not intend to use these titles in the future. *See Local 144, SEIU*, 40 OCB 25, at 2 (BOC 1987) (deleting vacant and obsolete titles).

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law (New York City Administrative Code, Title 12, Chapter 3), it is hereby

ORDERED that Certification No. CWR-44/67 (as previously amended) be, and the same hereby is, further amended to delete the following titles: Assistant Attorney (Taxes) (Title Code No. 30091), Assistant Attorney (Title Code No. 30110), Associate Attorney (Title Code No. 30126), Associate Attorney (Taxes) (Title Code No. 30097), Attorney (Title Code No. 30115), Attorney Trainee (Title Code No. 30101), Attorney (Taxes) (Title Code No. 30092), Attorney (Law Librarian) (Title Code No. 30113), Law Clerk (Title Code No. 30109), Senior Attorney (Title Code No. 30125), Senior Attorney (Taxes) (Title Code No. 30093), and Student Legal Assistant (Sanitation) (Title Code No. 06044).
