On April 11, 2022, the Organization of Staff Analysts ("Union") filed a petition, docketed as AC-1695-22, requesting that employees in the Director of Health Care Program/Planning Analysis title (Title Codes Nos. 002552, 002553, and 002554) be added to Certification No. 3-88, the Staff Analysts bargaining unit. NYC Health + Hospitals ("HHC") argued that the employees were managerial and/or confidential and did not share a community of interest with the employees already in the Staff Analysts bargaining unit and, therefore, should be excluded from collective bargaining.

On November 14, 2022, the Union and HHC signed a stipulation of settlement in

which they agreed that employees in the Director of Health Care Program/Planning

Analysis title are eligible for collective bargaining with the exception of certain employees

listed in Appendix A, who are designated managerial.
