On April 5, 2022, the Organization of Staff Analysts ("Union") filed a petition, docketed as AC-1693-22, requesting that employees in the Director of Health Care Program Planning/Analysis (HMH) title (Title Code No. 95950) be added to Certification No. 3-88, the Staff Analysts bargaining unit. The City of New York ("City") argued that the employees were managerial and/or confidential and therefore excluded from collective bargaining.

The parties requested that the matter be held in abeyance while they negotiated a settlement. On May 3, 2024, the Union and the City signed a stipulation of settlement in
