rwa mbere mu rugerekero rw'Ubutegetsi rw'Urukiko Rukuru, rusanga kuba haratanzwe ikirego cy'imbonezamubano mu Rukiko Rwisumbuye rwa Gasabo bivuze ko haregewe Urukiko rutabifitiye ububasha, rwanzura ko urubanza RC 0290/09/TGI/GSBO rwaciwe n'Urukiko Rwisumbuye rwa Gasabo ku wa 08/03/2012 ruwanweho.

Yajuririye icyo cyemezo mu Rukiko rw'Ikirenga asaba kugenerwa indishyi zo kuba yaravuwe nabi, agasezererwa adakize akangirika bikaba byaratumye atazongera kubyara ndetse bikanamutera igihombo cyaturutse ku guhora asiragira yihuza.

Uwajuriye asobanura impamu ze z'ubujurire avuga ko ubwo yageraga kwa muganga yasabye ko yabagwa kuko hari hashije igihe cy'imyaka 2 nubundi abyaye abazwe ariko abanga ntibamwumva baguma gutegereza ko abyara neza bigeze ni njoro nibwo mu saa mbili aba aribwo abaganga bafata icyemezo cyo kumubaga, nyuma yo kubagwa yakomeje kubona ibantu bidasanze by'uruzi bivanze n'amaraso, ibitaro byamusezereye ibyo bintu bikiza, nyuma y'iminsi 4 yagarutse kwa muganga kuko yabonaga biteye ubwoba, maze yandikirwa ibitaro; akaba asanga kuba ibitaro byari biziko adafite amahirwe ijana ku ijana yo kubyara neza kuko n'ubundi yari yarabyaye abazwe, hanyuma bigatinda ku mubaga kandi abaganga babona ko byananiranye kubyara neza, kuri ibyo hakiyongeraho kubagwa n'umuganga utari inzobere mu kuvura ababyeyi aribyo byamuteye indwara yo kujojoba. Asoza avuga ko ibyo avuga bishimangirwa na raporoyakozwe n'impuguke mu buvuzi bw'indwara z'abagore ku wa 11/06/2019 ndetse n'imvugo zabo, nabyo bigaragaza ko yabazwe nabi, bamusezerera adakize kandi ikibazo yari yagize cyagaragaye, bityo akaba asaba urukiko kwemeza ko Ibitaro Byitiriwe Umwami Fayisali byagize uburangare, bikabiryorezwa indishyi z'ighombo n'iz'akababaro kuko byamuteye uburwayi n'ighombo bitari bikwiye.

II. IBIBAZO BIGIZE URUBANZA N'ISEENGURWA RYABYO

Asobanura ko yatinze ku bise bituma umwana ananirwa, bigeze mu ma saa mbiri z'ijoro yumva agiye guturika umura, aba ari bwo abaganga bafata icyemezo cyo kumubaga, bikorwa mu gihe cy'iminota igeria kuri 45, ariko nyuma y'aho akomeza kubona ibantu bidasanzwe by'uruzi bivanze n'amaraso. Avuga ko byageze ku wa 21/11/2003, ibitaro bikamusezerera, ariko bya bantu by'uruzi bivanze n'amaraso bikomeza kuza ndetse n'icyo anyoye cyose kigahita gisohoka, bimutera ubwoba, asubira kwa muganga ku wa 24/11/2003, bamushyira mu bitaro. Asobanura ko kuri iyo nshuro bamushyizemo sonde ariko nayo ikajya inyuza mu gitsina ibyo anyoye mu gitsina aho kubinyuza ahasantze hanyura inkari.

[13] N.L akomeza avuga ko kuva ibitaro byari bizi ko adafite amahirwe ijana ku ijana yo kubyara neza kuko byari bifite amakuru y'uko yari amaze imyaka ibiri gusa abyaye abazwe, hanyuma agatinda kubagwa kandi abaganga babona ko kubyara neza byananiranye, kuri ibyo hakiyongeraho kubagwa n'umuganga mushya, utari inzobere mu kuvura ababyeyi kandi utaramukurikiranye nyamara kuva inda ifite amezi umunani yarakurikiranwe n'umuganga w'inzobere mu kubyaza witwa Dr Ntahonkiriye Gaspard ari byo byamuteye indwara yo kujojoba (fistule). Asoza avuga ko rapor yakoze n'impuguke mu buvuzi bw'indwara z'abagore ku wa 11/06/2019 ndetse n'imvugo zabo, nabyo bigaragaza ko yabazwe nabi, bamusezerera adakize kandi ikibazo yari yagize cyagaragaye, ari yo mpamvu asaba uru Rukiko kwemeza ko Ibitaro Byitiriwe Umwami Fayisali byagize uburangare, bikabiryorezwa indishyi kuko byamuteye uburwayi n'igihombo bitari bikwiye.

[14] Me Ndagijimana Augustin, umwunganira, avuga ko icya mbere kigaragaza uburangare bw'Ibitaro Byitiriwe Umwami Fayisali, ari uko umuganga N.L yasabye atari we wamubyaje ahubwo bikorwa n'undi utagaragara ku rutonde rw'abaganga bemewe mu Rwanda rwatangajwe mu kinyamakuru Imvaho Nshya. Asobanura ko ibitaro byirindirije gukora ibyo byagombaga gukora ku gihe, ko rapor y'abahanga ndetse n'imvugo zabo, byemeza ko ikibazo cya N.L gikomoka ku kuba yarabazwe atinze akanabagwa nabi, ariyo mpamvu asaba uru Rukiko kwemeza ko Ibitaro Byitiriwe Umwami Fayisali byakoze amakosa y'uburangare bikabiryorezwa indishyi.

Asobanura ko rapor y'abahanga ndetse n'ibyo bo ubwabo bavugiye mu Rukiko, byemeza ko umwana yari yamanutse ahagama mu matakko, mu gihe cyo kumukuramo, muganga akomeretsa uruhago ari nabyo byateye N.L indwara yo kujojoba, bigaragaza ko ibyabaye ari impanuka.

[16] Mu iburanisha ryabaye ku wa 19/06/2019, Dr Ndacyayisenga Victorien na Dr Gakindi Léonard, nk'abahanga mu buvuzi bw'indwara z'abagore biyambajwe n'Urukiko, barubwiye ko basuzumye N.L na dosiye ye iri mu Bitaro Byitiriwe Umwami Fayisali, basanga umuganga yarabonye ko nyababyeyi igiye guturika, ko umwana atangiye kunanirwa, aramubaga, nyuma yaho aba ari bwo inkari zitangira kujya zizana, agiye kwisuzumisha abaganga basanga harabayeho kwangirika kw'uruhago rw'inkari. Basobanuye ko umubyeyi iyo asabye kubagwa akabisinyira bikwiye guhita bikorwa, ko kuri we bamubaze kubera ko umwana yari atangiye kunanirwa, ariko umuganga wamubaze ntiyamenya ko yakomerekeje uruhago rw'inkari, bakaba babona byaratewe n'uko atari abimenyereye cyangwa atari abifitiye ubumenyi, ko ibyabaye kuri N.L bitari bikwiye kuba byarabayeho cyane cyane harebwe ko yabyariye mu Bitaro Byitiriwe Umwami Fayisali.

[17] Naho Dr Ntahonkiriye Gaspard, amaze kurahira, yemeje ko ari we wakurikiranye N.L, ko bari bumvikanye ko azabyara neza, yabura ibise akabona kubagwa, ageze mu bitaro asanga muri serivisi ya « maternité » hakoreye umuganga w’umu « généraliste » aba ari we umubyaza, ko icyatumye atamubyaza ari uko ibitaro byari byamuhaye akandi kazi.

UKO URUKIKO RUBIBONA

[18] Ingingo ya 259 y’Igitabo cya gatatu cy’urwunge rw’amategeko mbonezamubano iteganya ibikurikira : « umuntu ntaryozwa ibyangiritse biturutse ku bikorwa bye bwite gusa, ahubwo anaryozwa ibyangiritse kubera umwete we muke cyangwa ubwitonzi bwe buke. » Ingingo ya 260 y’iryo tegeko nayo igateganya ibikurikira : « Umuntu ntaryozwa gusa ibyangiritse kubera ibikorwa bye bwite, ahubwo anaryozwa ibyangirijwe n’ibikorwa by’abantu yishingiye cyangwa n’ibantu ashinzwe kurinda. »

Harimo kandi raporo yakozwe n’inzobere ku wa 11/06/2019, ivuga ko nyuma yo kuba yarabazwe ku mbyaro ya kabiri, N.L yari afite amahirwe angana na 80% yo kubyara neza, uretse ko yashoboraga guturika umura, bikaba kuri we cyangwa ku mwana, byamugiraho ingaruka cyangwa bikabatera uburwayi bwa « infections), ko kuba yararwaye indwara ya VVF byatewe n’ibikorwa bya muganga kabone n’ubwo mu busanzwe, ibyago byo kurwara iyo ndwara byabarirwa hagati ya 0.5% na 0.28%, ko yamaze amezi ane atabasha guhagarika inkari, ko ibikorwa by’abaganga byaramiye ubuzima bw’umwana ariko ko nubwo yababwiye ko umugabo yamutaye, nk’abahanga, batamenya ingaruka z’ubwo burwayi ku mibereho ye.

- (iii) kuba kutita kuri izo nshingano hari ibyo byangirijeho urega (the breach of duty of care caused the claimant damage).

Staruss avuga ko umuganga cyangwa umuforomo uri mu bitaro nk'umukozi wabyo, atuma ibitaro biryozwa ibikorwa by'uburangare, we nk'umukozi, yakoze mu mbibi z'akazi ke (vicarious liability) ariko ko ibitaro bishobora no kuryozwa kuba bitahaye umuganga ibikoresho bikwiriye, kutita ku nyubako zabyo cyangwa guhitamo gukoresha cyangwa kugumana abakozi badashoboye akazi (corporate liability)², ibi byongera kandi gushimangirwa na Pierre Aberkane uvuga ko amakosa yakorewe mu kazi, abayakorewe bakwiye gukurikirana umukoresha³, byose bigaragaza ko Ibitaro Byitiriwe Umwami Fayisali aribyo, mu bushobozi bwabyo, byari bifite inshingano zo kwita kuri N.L kugirango abyare neza.

[31] Me NDAGIJIMANA Augustin avuga ko Ibitaro Byitiriwe Umwami Fayisali byamuteye ububabare ku mubiri, abagwa nabi, asezererwa adakize, arangirika ku buryo atazongera kubyara kuko bamufunze « trompes », ko uretse kujojoba, byamuviriyemo indwara y'umugongo n'igifu, bimutera ipfunwe, umugabo aramuta bitewe no kutabasha kuzuza inshingano z'abashakanye, byose hamwe akaba abisabira indishyi z'akababaro zingana na 50.000.000 Frw. Van Damme (we shall settle her medical bill upon its presentation to KFH), N.L akaba ataragaraza ko yazanye inyemezabuguzi ibitaro bikanga kumwisyura nk'uko byari byabyiyemeje, naho ku yandi mafaranga yaba yarakoreshe, nta kimenyetso kiri muri dosiye kigaragaza ingano y'ibyo yatanze yivuza ku buryo yabisubizwa, bityo uru Rukiko rukaba ntaho rwahera rwemeza ishingiro rya 10.000.000 Frw y'indishyi z'igihombo asaba.
