Incamake y'ikibazo: Urubanza rwatangiriye mu Rukiko rw'Isumbuye rwa Gasabo aho Mutabazi yaregaga Murenzi ko imyubakire ye idahwitse yatumye amazi y'imvura amusenyerera igikuta cy'urubangu ndetse byangiriza n'imodoka ze ebyiri zari muri « parking ». Mutabazi yuririye kuri icyo kirego yatanze ikirego cyihutirwa asaba itambama ku mitungo itimukanwa ya Murenzi kugira ngo azabone ubwishyu mugihe yaramuka atsinze urubanza. Murenzi yajuririye urwo rubanza rw'ikirego cy'ihutirwa asaba Urukiko Rukuru ko itambama riguma gusa ku mitungo imwe itimukanwa, hagati aho urubanza mu mizi rwaraburanishijwe mu Rukiko rw'Isumbuye rwemeza ko isenyuka ry'urugo rwa Mutabazi ryatewe n'umyubakire idakwiye ya Murenzi, rugenera indishyi Mutabazi.

Mutabazi yatanze inzitizi yo kutakira ikirego cya Murenzi kuko ngo ibyo asaba yabiburanye mu kirego cyihutirwa cyaciriweho urubanza rwabaye itegeko, kandi ko kiramutse cyakiriwe, rwakwemeza ko nta cyihutirwa kiriho kuko atagaragaza ko yasabye umwenda akabura icyo atangaho ingwate. Urukiko Rukuru rwaciye urubanza ruvuga ko ibyemezo byafashwe ku birego byihutirwa biba ari iby'agateganyo kandi ko bishobora guhinduka igihe icyo ari cyo cyose, bityo ko ari uburenganzira bwa Murenzi bwo kwongera kuregera icyo abona cyihutirwa. Ku birebana n'ubusabe bwa Murenzi, Urukiko rwasanze ko, kuba imitungo ye ifatiriwe, ubwabyo bitagize impamvu y'ubwihutirwe.

Murenzi yajuririye Urukiko rw'Uburujire avuga ko kuvutswa uburenganzira ku mutungo we bibangamiye ubucuruze bwe, nyamara ngo umutungo asaba ko ugumaho itambama ukubye inshuro 2 indishyi Mutabazi yagenewe, bityo ko byaba ari ugukoresha nabi uburenganzira umuntu yemererwa (abus de droit).

Mutabazi avuga ko indishyi yagenewe yazijuririye bityo ko ingano yazo ishobora kwiyongera mu bujurire, kandi ko Murenzi Alphonse atagaragaza ko yakeneye ingwate ku mwenda runaka ngo ayibure, ko ahubwo agamije kuyivanaho ngo aburizemo ubwishyu asabwa. Mutabazi yuririye ku bujurire bwa Murenzi asaba ko iki kirego kitakwakirwa kuko ibyo asaba byaciriweho urubanza rwabaye Itegeko.

Murenzi yisobanuye kuri iyi ngingo avuga ko ibyemezo mu manza zihutirwa birangwa n'ihame ko ari iby'agateganyo, ko bishobora guhinduka igihe cyose bibaye ngombwa, ko bidashobora kugira kamere y'imanza zabaye itegeko. Avuga ko, gusaba ko imwe mu mitungo ivanwa ku

Mutabazi Abayo J.Claude yasabye itambama ku mitungo itimukanwa ya Murenzi Alphonse kugira ngo azabone aho akura ubwishyu mu gihe yaramuka atsinze urubanza.

[2] Murenzi Alphonse yasabye ko imwe mu mitungo ye yavanwa ku rutonde rw'iyatambamiwe, Urukiko Rukuru, mu kirego cyihutirwa RCA 00337/2018/HC/KIG, rwemeza ko itambama riguma gusa ku mitungo UPI: 1/03/07/04/2675, UPI: 1/02/09/02/1368, UPI: 1/03/07/04/2677 na UPI: 2/03/03/06/4687. Hagati aho urubanza mu mizi RC 00203/2018/TGI/GSBO rwaraburanishijwe, ku wa 08/11/2019 Urukiko Rwisumbuye rwemeje ko

isenyuka ry'urugo rwa Mutabazi Abayo Jean Claude ryatewe n'imyubakire idakwiye ya Murenzi Alphonse, agenerwa indishyi ku byangiritse byose zingana na 22,159,538Frw na USD 6,173.

[6] Murenzi Alphonse yunganiwe na Me Turatsinze Emmanuel na Me Uwizeyimana J.Baptiste yajuririyeye avuga ko kuvutswa uburenganzira ku mutungo we bibangamiye ubucuruzi bwe, nyamara ngo umutungo asaba ko ugumaho itambama ukubye inshuro 2 indishyi Mutabazi Abayo J.Claude yagenewe, bityo ko byaba ari ugukoresha nabi uburenganzira umuntu yemererwa (*abus de droit*) gutambamira imitungo ifite agaciro ka 400.000.000Frw kubera indishyi zitageze kuri 30.000.000Frw.

[7] Mutabazi Abayo yunganiwe na Me Mudenge avuga ko indishyi yagenewe yazijuririyeye bityo ko ingano yazo ishobora kwiyongera mu bujuriye, kandi ko Murenzi Alphonse atagaragaza ko yakeneye ingwate ku mwenda runaka ngo ayibure, ko ahubwo agamiye kuyivanaho ngo aburizemo ubwishyu asabwa. Mutabazi Abayo yuririyeye ku bujuriye bwa Murenzi Alphonse asaba ko iki kirego kitakwirwa kuko ibyo asaba byaciriweho urubanza rwabaye itegeko.

Nubwo ubujuriye bwa Mutabazi Abayo J.Claude bwuririyeye ku kirego cyatanzwe na Murenzi Alphonse, nyamara bitewe nuko kigamiye kutakira ikirego (*fin de non recevoir*), iki ni cyo kibazo gikwiye gusuzumwa mbere.

II. ISESENGURA RY'URUBANZA

[12] Ingingo ya 185 y'Itegeko N° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'ianza z'imbenezamubanno, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi iteganya ko “ iyo hari ikirego cy'iremezo, ariko hagomba kugira icyemezwa by'agateganyo mu buryo bwihuta ku rubanza rwaregewe urukiko rutaraburanishwa, ikirego cyihutirwa gishyikirizwa umucamanza ushinzwe kurangiza impaka zihutirwa w'aho zigomba gukemurirwa (...).

Claude yunganiwe na Me Mudenge Richard avugaga ko itambama ryakorewe ku mitungo ya Murenzi Alphonse yakozwe ku buryo bukurikije amategeko, ko kandi ubwe ariwe wisabiye Urukiko Rukuru mu rubanza RCA 00337/2018/HC/KIG, ko ari yo isigara ku rutonde rw'itambamiwe mu gihe yasabaga ko indi ikomorerwa. Mutabazi Abayo avugaga ko nta kosa Urukiko rwakoze kuko rwerekanye ko nta cyihutirwa cyatuma imitungo uya Murenzi ivanirwaho itambama kuko nawe atagaragaza ubwihutirwe avugaga.

[19] Urukiko rurasanga itamba ku mitungo ya Murenzi Alphonse, ryarakozwe mu rwego rwo kwizeza Mutabazi Abayo Jean Claude ko azabona ubwishyu aramutse atsindiye indishyi amurega. Ibyemezo bifashwe kuri ubu buryo bifatwa mu nzira y'ibirego byihutirwa nk'uko bisobanurwa n'umuhanga mu mategeko, Serge Guinchard³.

[20] Urukiko rurasanga, nubwo iki kirego kiburanishwa mu nzira y'ibirego byihutirwa, nyamara kandi ikigenderewe (kwizeza urega ko azabona ubwishyu mu mutungo w'uwo arega), ni cyo shingiro ry'impinduka zakorerwa icyemezo cyafashwe. Nk'uko Murenzi Alphonse n'ubwunganizi bwe babivugaga, ntabwo ubwihutirwe bw'ikirego cyeye gisaba kuvana imwe mu mitungo ye ku rutonde rw'ibyatambamiwe bugomba kureberwa mu kuba imitungo ye yatambamiwe nta kibazo kiyugarije, ahubwo harebwa niba uburenganzira asaba ku mutungo we

[21] Urukiko rurasanga, biri mu nshingano z'Urukiko gushyira mu gaciro icyatuma Mutabazi Abayo atabura ubwishyu mu gihe yaba atsinze n'icyatuma Murenzi Alphonse atabuzwa uburenganzira ku mutungo we ku buryo burenze icyishingiwe. Urukiko rurasanga, rukurikije imiterere y'iki kirego, Murenzi Alphonse atari we ukwiye kubazwa icyo yifuza gukoresha umutungo we, ahubwo Mutabazi Abayo J.
