

## KAYUMBA v SIMACO LTD N'ABANDI

[Rwanda URUKIKO RW'UBUJURIRE – 00064/2019/CA (Karimunda, P.J., Nyirandabaruta na Munyangeri, J.) 03 Ukwakira 2019]

*Ingwate – amasezerano y'ingwate – Ihame rikuru kubijyanye n'uburenganzira ku mutungo ari uko ari ntavogerwa (peaceful enjoyment of property : usus, fructus, abusus). Iyo hari ikirego cy'uko ubwo burenganzira butubahirijwe hagomba gusuzumwa niba ibyakozwe kuri uwo mutungo byarakurikije amatekego kandi ko byari bishingiye ku mpamvu zemewe kandi zumvikana – Umutungo wagurishijwe muri cyamunara mu buryo bunyuranyije n'Amabwiriza y'Umwanditsi Mukuru, iyo cyamunara iteshwa agaciro, ibintu bigasubira uko byari biri uwo mutungo utaragurishwa. Amabwiriza y'Umwanditsi Mukuru agenga ibyerekeye gukodesha, kugurisha muri cyamunara ndetse no kwegukana ingwate, ingingo ya 10 , niya 12.*

**Incamake y'ikibazo:** IMBANK yahaye amasezerano Sosiyete SIMACO Ltd inguzanyo, itizwa ingwate yimitungo itimukanwa na zuwitwa Kalisa Jérémie na Ndikumana Léoncie nyuma yaho, amasezerano ntiyubahirijwe, ingwate zitezwa cyamunara n'ushinzwe kugurisha ingwate witwa Kayumba, ariko abatanze ingwate bavuze ko cyamunara yakozwe inyuranyije n'amategeko bituma batanga ikirego mu rukiko rw'ubucuruzi basaba ko iteshwa agaciro. Ururukiko rwanzuye ruvuga ko cyamunara yakozwe igumana agaciro kayo kuko yubahirije amategeko, bityo ko ikirego cyabareze nta shingiro gifite.

SIMACO Ltd ntiyishimiye imikirize y'urubanza maze ijurira mu rukiko rukuru rw'ubucuruzi ivuga ko cyamunara yakozwe itubahirije amabwiriza ya cyamunara kuko yakozwe ku masaha no ku munsi inyuranye niyari kumatangazo, isaba ko yateshwa agaciro, ivuga kandi ko nta n'umwe wigeze agaragaza procurement ya sosiyete bari bahagarariye nk'uko byari byategetswe mu mabwiriza, ko ingwate yagurishijwe ku mafaranga make. Uru rukiko rwemeje ko cyaunara iteshejwe agaciro, kuko nyuma yisesengura rwasanze koko ko itarubahirijwe.

Ushinzwe kugurisha ingwate yajuririye mu rukiko rw'ubujurire asaba ko hasuzumwa niba itangazo rya cyamunara ritarubahirije ibihe biteganywa n'amabwiriza y'Umwanditsi Mukuru kuko we asangaibyo bihe byarubahirijwe.

Safari Jean Claude yagobotse ku bushake mu rubanza, avuga ko arufitemo inyungu kuko ari we waguze ikibanza kimwe mu byagurishijwe muri cyamunara, avuga kandi ko nawe yaje kukigurisha nundi muntu. Abandi baburanyi bavugagako ukugoboka kutemewe mu bujurire, urukiko nyuma yisesengura rwasanze icyo itegeko ribuza ari ukugobokeshwa ku gahato mu Rukiko rw'Ikirenga cyangwa mu Rukiko rw'Ubujurire, rusanga nta kibuza umuburanyi kugoboka ku bushake muri izo nkiko mu gihe afite inyungu mu rubanza, bityo ko ukugoboka kwa Safari kubahirije ibitenganyijwe n'amategeko, akaba yemerewe kugoboka.

Ushinzwe kugurisha ingwate asaba urukiko kwemeza ko cyamunara yubahirije ibiteganywa n'amatageko cyane ko SIMACO Ltd itabasha kugaragaza ukuntu amabwiriza ya cyamunara atubahirijwe nkuko ibivuga, bityo akaba asaba yuko urubanza rwajuririwe ruhindutse mu ngingo zarwo zose.

Uhagarariye RDB we avuga ko asanga kuba SIMACO Ltd itabashije kugaragaza icyayibingamiye mu kutubahiriza ibihe by'iminsi irindwi mu kinyamakuru cyanditse , no kuba kutubahiriza iminsi

irindwi ntacyo byangije, avuga ko ayo makosa atahanishwa gusesa cyamunara cyane cyane ko umurongo watanzwe n'Urukiko rw'Ikirenga mu rubanza rwa Habimana Vedaste na Banki ya Kigali, ari uko bitihagije ko usaba ko cyamunara iseswa agaragaza ko hari imigenzo itarubahirijwe ahubwo agomba no kugaragaza icyo kutubahiriza iyo migenzo byamubangamiyeho.

Safari Jean Claude waguze ikibanza avuga ko yakiguze mu buryo bwemewe n'amategeko, avuga kandi ko kutubahiriza iminsi irindwi igithe cy'igurisha bifatwa nk'amakosa y'imigenzo (vice de procédure), avuga ko bene ayo makosa adakosorwa hateshwa agaciro ibyakozwe.

Kalisa Jérémie uhagarariye SIMACO Ltd, bamwe mu bantu RDB yitwaza ko bari bahari cyamunara ikorwa ari abahamagawe mu muhanda, bahabwa ruswa kugirango buzuze umubare ariko baburizemo no kuzamura igiciro, ko yabiregeye mu Bugenzacyaha dosiye ikaba igikurikiranwa, ubwo buriganya akaba aribwo bukwiye gutuma cyamunara iteshwa agaciro.

Byageze aho SIMACO Ltd ntiyubahiriza ibyo yari yumvikanye na I&M Bank Rwanda Ltd, bituma ku wa 05/04/2019, Kayumba Godfrey, ushinzwe kugurisha ingwate, ateza cyamunara izo ngwate kugirango hishyurwe umwenda SIMACO Ltd ibereyemo I & M Bank Rwanda Ltd. SIMACO Ltd na Kalisa

Jérémie bavuze ko cyamunara yakozwe mu buryo bunyuranyije n'amategeko, batanga ikirego mu Rukiko rw'Ubucuruzi basaba ko iteshwa agaciro.

## **II. IBIBAZO BIGIZE URUBANZA N'ISESENGURWA RYABYO**

Asobanura ko itangazo ryasohotse mu kinyamakuru cyanditse ari ryo Urukiko rwavuze ko ritubahirije ibihe by'iminsi irindwi iteganywa n'Amabwiriza y'Umwanditsi Mukuru, ariko ko Urukiko rwabisesenguye mu buryo butari bwo kuko icyo we yasabwaga ari "ugutanga" itangazo mu minsi irindwi, naho ibyo kurtangaza bikaba bitaramurebaga, ko nubwo byafatwa ko yari ashinzwe no gutangaza, asanga yarabikoze kuko amatangazo yatanzwe kuri radiyo, televiziyo n'ayamanitswe ku Murenge yari yihagije. Avuga ko nawe yemera ko akamaro ko gutangaza cyamunara ari ukugirango rubanda hamwe na nyir'umutungo bamenyeshwe ibigije kuba, umutungo uzatezw a cyamunara na nyirawo ndetse n'igihe bizabera, ariyo mpamu asanga yarubahirije ibyo amategeko ateganya.

[9] Me Mugabo Samuel, umwunganira, avuga ko iyo asuzumye ibyabaye asanga itangazo ryasohotse mu kinyamakuru ryaramaze iminsi itandatu, avuga ariko ko ibyo bidaturuka k'ushinzwe kugurisha ingwate ahubwo biterwa n'uburyo itegeko ryanditse n'imikorere y'ibinyamakuru byanditse, kuko itangazo risohoka ku munsi ukurikira uwo ryatangiweho. Asobanura ko hashingiwe ku kuba hagomba gusohoka amatangazo atatu muri nimero zitandukanye z'ikinyamakuru, bidashoboka ko iminsi irindwi yubahirizwa kuko hagati y'itangazo

rya gatatu n'umunsi wa cyamunara iminsi irindwi itarimo. Avuga ko kugeza ubu SIMACO Ltd itagaragaza icyayibangamiye muri cyamunara yakozwe hatubahirijwe amabwiriza kuko niyo ibihe byubahirizwa ntacyo byari kuyimarira bitewe n'uko umuguzi wa mbere yabonetse ku nshuro ya kane, akaba asanga mu gihe cyose SIMACO Ltd itagaragaza icyayibangamiye, uru Rukiko rukwiye kwemeza ko cyamunara yubahirije ibiteganywa n'amatageko, rugategeka ko urubanza rwajuririwe ruhindutse mu ngingo zarwo zose.

[10] Me Kayigi Kajuga Leo, uhagarariye Ikigo cy'Ighugu cy'Iterambere (RDB), avuga ko iminsi 7 iteganyijwe mu Mabwiriza y'Umwanditsi Mukuru itarubahirijwe, kandi ko ari amakosa. Asobanura ko akamaro ko gutangaza cyamunara ari ukugirango nyir'umutungo na rubanda bamenye ko hari ingwate igiye kugurishwa nibishoboka haboneke abaguzi benshi, umutungo ugurwe ku giciro cyiza, naho akamaro ko gутегереza umunsi wa karindwi akaba ari ukugirango ababimenye nyuma bahabwe amahirwe yo gupiganwa. Asobanura ko atemeranywa na Kayumba Godfrey ko "gutanga" itangazo byihagije kuko inshingano z'ushinzwe kugurisha ingwate ari "ugutangaza", bivuze ko agomba gukurikirana akamenya ko itangazo ryatangajwe.

[11] Icyakora, asobanura ko amatangazo yatanzwe ahantu hatandukanye, umunsi wa cyamunara ugeze, haboneka abaguzi barindwi mu gihe Amabwiriza ateganya ko iyo habonetse batanu cyamunara ikorwa, SIMACO Ltd ikaba itagaragaza icyayibingamiye mu kutubahiriza ibihe by'iminsi irindwi mu kinyamakuru cyanditse nyamara umurongo watanzwe n'Urukiko rw'Ikirenga mu rubanza Habimana Vedaste yaburanaga na Banki ya Kigali,<sup>11</sup> ari uko bitihagije ko usaba ko cyamunara iseswa agaragaza ko hari imigenzo itarubahirijwe ahubwo agomba no kugaragaza icyo kutubahiriza iyo migenzo byamubangamiyeho, ariyo mpamvu asanga mu gihe kutubahiriza iminsi irindwi ntacyo byangije, ayo makosa atahanishwa gusesa cyamunara, cyane cyane ko ari n'amakosa akunzwe gukorwa ku buryo gufata bene icyo cyemezo byagira ingaruka zikomeye ku bukungu bitewe n'uko hari cyamunara nyinshi zabaye zitubahirije iyo minsi.

[19] Urukiko rurasanga na none ibyo uburanira Umwanditsi Mukuru avugisha urubanza Habimana Vedaste na Banki ya Kigali baburanye na Asiimwe Frank na bagenzi be by'uko iyo nyir'umutungo atagaragaje icyo kutubahriza ibihe bya cyamunara byamwangije, iyo cyamunara idateshwa agaciro, nta shingiro bikwiye guhabwa, kuko ataribyo byemejwe muri urwo rubanza. Muri urwo rubanza nyir'umutungo yari yasabye ko hakorwa irindi genagaciro bitewe n'uko iryakozwe ryari ryatubije bikabije agaciro k'umutungo katanzweho ingwate muri banki ntibyakorwa, byongeye kandi ugurisha ingwate ararengera yiha inshingano z'Umwanditsi Mukuru atabyemerewe. Mu gika cya 45 cy'urwo rubanza, Urukiko rusanga « *invugo y'ababuranira Habimana Vedaste, Bank of Kigali Ltd na Musinguzi Hannington ko kuba Asiimwe Frank yarashyikirijwe kopi y'inyandiko y'amabwiriza na Me Habimana Vedaste ntacyo byamwangirije, ikaba taba impamu yo gutesha agaciro cyamunara, cyane cyane ko imigenzo ya cyamunara atari ndemyagihugu, itahabwa ishingiro, kuko muri rusange amabwiriza yashyiriweho kugirango uburenganzira bwa buri ruhande cyamunara ireba bwubahirizwe kandi ibantu bikorwe kuri gahunda, kuba bitarubahirijwe birahagije kugirango Asiimwe Frank asabe ko bikorwa mu buryo bwateganyijwe bitabaye ngombwa atanga ibimenyetso y'ibyangirijwe.* »<sup>2</sup>

Kuwugurisha ibihe byateganyijwe n'amategeko bitaragera bikaba byatuma nyir'umutungo cyangwa abandi bifuza kuwucungura baburizwamo, abafite ibyo bari

kubaza kuri uwo mutungo bikabambura ubwo burenganzira ndetse bikaba byatesha amahirwe abaguzi baba bacyisuganya kugirango bazawugure ku giciro cyiza. Ibi byose bikaba byatuma nyir'umutungo ndetse n'abandi babihomberamo mu buryo budakwiye, ariyo mpamvu, mu gihe u Rwanda ruri mubihugu byateganyije igithe gito gishoboka cyo gutangaza cyamunara mbere y'uko ikorwa,<sup>5</sup> abashinzwe kugurisha ingwate bakwiye kubahiriza ibiteganywa n'amabwiriza, byaba bitubahirijwe, ibyakozwe bigateshwa agaciro kuko biba byanyuranyije n'amategeko.
