Incamake y'ikibazo: Hakizimana yatwaye ibikoresho by'ubwubatsi bya kampani Gukora Ni Ngombwa Ltd yiyitirira ko abitumwe na Gasabo Design Ltd maze ajya kubigurisha Nyabugogo, bigurwa na Dushimimana waje kubirindishwa mu gihe cy'ubugenzacyaha kuko ariho byafatiwe. Ubushinjacyaha bwaramukurikiranye ku cyaha cy'ubwambuzi bushukana, bumurega mu Rukiko rw'Ibanze rwa kacyiru rumutegeka gusubiza Gukora Ni Ngombwa Ltd ibyuma bye no kumwishyura indishyi z'akababaro. Iki cyemezo yakijuririye mu Rukiko Rwisumbuye rwa Gasabo ariko hagumishwaho imikirize y'urubanza y'Urukiko rw'Ibanze rwavuzwe haruguru.

Mu gihe cyo kurangiza urwo rubanza, Hakizimana yasabwe n'Umuhesha w'inkiko utari uw'umwuga kubahiriza ibyategetswe muri urwo rubanza ariko we avuga ko Gukora Ni Ngombwa Ltd izi aho ibyuma byayo biri bituma uyu Muhesha w'inkiko yandikira Dushimimana amusaba gusubiza ibyuma nyirabyo, akabikora mu masaha mirongo ine n'umunani ariko ntiyabikora. Ibi byatumye Gukora Ni Ngombwa Ltd atanga ikirego mu Rukiko rw'Ibanze rwa Kicukiro, isaba Urukiko gutegeka Dushimimana gusubiza ibyuma yabonye mu buriganya ariko uru rubanza rutaracibwa yahise atambamira imitungo ye afatanyije n'umugabo we ashingiye ku ngingo ya 213 y'Itegeko N° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsu ryakoreshwaga icyo gihe kugira ngo natsindwa izabone ubwishyu, Ikigo cy'ubutaka kirabimwemerera gishyiramo iryo tambama. Uru Rukiko rwasanze Dushimimana atari we ugomba gusubiza ibyuma yarindishijwe ahubwo ko byabazwa Hakizimana.

Nyarugenge, rwasanze ubujurire bwa Gukora Ni Ingombwa bufite ishingiro maze rwemeza ko Dushimimana agomba kuyisubiza ibyuma byayo ndetse akayiha n'indishyi.
