### **I. IMITERERE Y'URUBANZA**

[1] Uru rubanza rwatangiriye mu Rukiko rw'Ubucuruzi rwa Nyarugenge MICON REAL LINE Ltd isaba gusesa amasezerano yagiranye na ECOBANK RWANDA Plc yo ku wa 07/06/2016 y'inguzanyo ingana na 500.000.000 Frw, kuko ECOBANK RWANDA Plc itubahirije amasezerano bagiranye, igahabwa n'indishyi zijyanye nabyo.

[2] Urukiko rw'Ubucuruzi rwa Nyarugenge rwaciye urubanza No RCOM01153/2018/TC/NYGE ku wa 21/03/2018, rwemeza ko hari amafaranga yagiye ashirwa

kuri konti ya MICON REAL LINE Ltd hashingiwe ku masezerano yo ku wa 07/06/2016, aho ku wa 10/06/2016 hashyizweho 80.000.000 Frw, naho ku wa 04/11/2016 hashyirwaho izindi 297.359.448 Frw, ikindi ni uko MICON REAL LINE Ltd yari isanzwe ifitemo umwenda, maze Banki mu gihe cyo kuyiha umwenda ikabanza kwiyishyura umwenda wari usanzwemo, ko ibyo bigaragaza ko amasezerano yo ku wa 07/06/2016 yagiye ashirwa mu bikorwa, akaba atagomba guseswa, rutegeka MICON REAL LINE Ltd kwishyura ECOBANK RWANDA Plc indishyi zo gushorwa mu manza zingana na 600.000 Frw, ikanishyura amafaranga yishyuwe umuhanga wifashishijwe n'Urukiko.

[3] MICON REAL LINE Ltd ntiyishimiye imikirize y'urubanza, ijurira Urukiko Rukuru rw'Ubucuruzi ivuga ko Urukiko rw'Ubucuruzi rwa Nyarugenge rwitiranyije iyubahirizwa ry'amasezerano yo ku wa 07/06/2016 n'andi masezerano y'inguzanyo yabaye mbere, maze rwitirira ayo masezerano ya mbere ishira mu bikorwa ry'amasezerano yabaye ku wa 07/06/2016.

[4] Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza No RCOMA 00347/2019/HCC ku wa 31/12/2019, rwemeza ko amasezerano yitwa "Convention d'ouverture de crédit avec constitution d'hypothèque" yo ku wa 07/06/2016 yabaye hagati ya ECOBANK RWANDA Plc na MICON REAL LINE Ltd, aseswa, rutegeka ECOBANK RWANDA Plc kwishyura MICON REAL LINE Ltd 1.000.000 Frw y'igihembo cya Avoka na 60.000 Frw y'amagarama y'urubanza.

[5] ECOBANK RWANDA Plc ntiyishimiye imikirize y'urubanza ijuririra Urukiko rw'Ubujurire irusaba gusuzuma niba amasezerano yo ku wa 07/06/2016 yabaye hagati ya MICON REAL LINE Ltd na ECOBANK RWANDA Plc yihagije ubwayo ku buryo yafatwa nk'amasezerano y'umwenda, no gusuzuma niba yarubahirijwe ku ruhande rwayo, niba ECOBANK RWANDA Plc yari ifite impamvu zumvikana zo kudaha MICON REAL LINE Ltd umwenda wa Letter of Credit wa USD 254.000 na Performance Guarantee Extension ya USD 186.562, isaba indishyi zitandukanye hamwe n'igihembo cya Avoka.

[6] MICON REAL LINE Ltd nayo yatanze ubujurire bwuririye ku bundi ivuga ko ECOBANK RWANDA Plc yakomeje kuyishora mu manza kandi ari yo ntandaro y'uru rubanza kubera ko itubahirije amasezerano aburanwa, ko basanga ECOBANK RWANDA Plc ikwiriye kwirengera ingaruka z'uru rubanza, isaba ko MICON REAL LINE Ltd yakwishyurwa 2.500.000 Frw y'igihembo cya Avoka na 500.000 Frw y'ikurikiranarubanza kuri uru rwego kandi igahabwa 200.000.000 Frw y'indishyi zo kwica amasezerano.

[7] Urubanza rwaburanishijwe mu ruhamwe ku wa 23/12/2020, ECOBANK RWANDA Plc, iburanirwa na Me Bimenyimana Eric, MICON REAL LINE Ltd iburanirwa na Gacinya Chance Denys, umuyobozi wayo, yunganirwa na Me Uwamahoro Marie Grace.

## **II. IBIBAZO BIGIZE URUBANZA N'ISESENGURWA RYABYO**

[8] Me Bimenyimana Eric, uburanira ECOBANK RWANDA Plc, avuga ko amasezerano yabaye ku wa 07/06/2016 atari amasezerano y'inguzanyo, ko ahubwo ari ayo gutanga ingwate ku

mwenda, asobanura ko icyo ECOBANK RWANDA Plc inenga icyemezo cy'Urukiko Rukuru rw'Ubucuruzi ari uko cyashingiye ku mpamvu zidafite ishingiro, kuko kuba impande zombi zarumvikanye ingano y'umwenda wa 500.000.000 Frw, ijanisha rya 18%, ndetse no kuba umwenda waragombaga kumara imyaka 10 ukarangira ku ya 07/06/2026, kuba impande zombi zarumvikanye ku ngwate ndetse zikanandikishwa ku Mwanditsi Mukuru, kuba umutwe w'amasezerano ugagaragaza ubwoko bwayo bidahagije kugira ngo amasezerano yabaye hagati y'impande zombi yitwe amasezerano y'inguzanyo.

[9] Akomeza asobanura uburyo Banki yari yumvikanye na MICON REAL LINE Ltd, burimo kuzongera gukora amasezerano no kwandikisha ingwate muri RDB cyane ko izo ngwate zari zisanzwe zaratanzwe ku mwenda wa 250.000.000 Frw nyamara Urukiko rukaba rwarabyirengagije byose rukemeza ko ari amasezerano y'umwenda kuko umwenda udakwiye kwitiranywa n'undi kandi nyamara n'ubundi amasezerano yo gutanga ingwate akorerwa ku mwenda, ko bitabaye ibyo ntacyo iyo ngwate yaba yishingira, ko rero aya masezerano adakwiye kwitiranywa n'amasezerano y'inguzanyo. Akomeza avuga ko amasezerano yakozwe ingwate zari zisanzwe zihari ko batari kurenza 500.000.000 Frw cyane ko ntaho MICON REAL LINE Ltd yigeze isaba ayo mafaranga bita inguzanyo.

[10] MICON REAL LINE Ltd, mu izina ry' Umuyobozi wayo Gacinya Chance Denys, mu kwiregura avuga ko ibyo Me BIMENYIMANA Eric avuga atari byo kuko bandikiye ECOBANK RWANDA Ltd ku wa 21/12/2015 basaba inguzanyo ya 700.000.000 Frw, bemerwa 500.000.000 Frw kandi n'Urukiko rwagaragaje ko ku wa 07/06/2016 habayeho amasezerano y'inguzanyo aherekejwe n'ingwate (convention d'ouverture de crédit avec constitution d'hypothèque), ko muri ayo masezerano impande zombi zumvikanye ku ngano y'umwenda ugurizwa ungana 500.000.000 Frw, kw'ijanisha ry'inyungu (18%), ku gihe umwenda wagombaga kumara cy' imyaka icumi, no ku ngwate zigomba gutangwa zikanandikishwa ku Umwanditsi Mukuru, ko ibyo byose bigaragaza ko amasezerano yabaye hagati y'impande zombi ari amasezerano y'iguriza yari yihagije. Ashingira ku ibaruwa yo ku wa 21/12/2015 ndetse n'amasezerano yabaye ku wa 07/06/2016 mu ngingo ya 2 n'ya 5 ashimangira ko ayo masezerano ari ay'inguzanyo.

[11] Me Uwamahoro Marie Grace, uburanira MICON REAL LINE Ltd, nawe avuga ko amasezerano yabaye hagati ya MICON REAL LINE Ltd na ECOBANK RWANDA Plc ku wa 06/07/2016 ari ay'inguzanyo atari ay'ingwate kuko bibaye uko bivugwa ntabwo bari bafite inshingano zo kuyashyira mu bikorwa, bikaba nta n'impamvu yari gutuma MICON REAL LINE Ltd ijya kuregera kwica amasezerano, nyamara ko ibivugwa na ECOBANK RWANDA Plc atari ukuri kubera ko ayo masezerano MICON REAL LINE Ltd yayakoze ishaka amafaranga yo gukora isoko yari yatsindiye ariko birangira itayahawe isoko bararitwara.

[12] Me Uwamahoro Marie Grace avuga kandi ko ibivugwa mu ngingo ya 3 n'ya 4 z'amasezerano bigaruka ku ijambo "crédit" bisobanuye ko icyo ECOBANK RWANDA Plc yatanze ari inguzanyo isabwamo ingwate. Akomeza avuga ko izo ngwate zandikishijwe muri RDB nk'uko byari mu masezerano, akaba abona ku ruhande rwa MICON REAL LINE Ltd barashyize mu bikorwa inshingano zabo mu masezerano ariko ECOBANK RWANDA Plc yo ikaba yaranze gushyira mu bikorwa ibyo yemeye.

[15] Dosiye igaragaramo amasezerano yo ku wa 07/06/2016 yakozwe hagati ya ECOBANK RWANDA Ltd, MICON REAL LINE Ltd, Arlette Hosana, Didier Ntwari Kayihura<sup>1</sup>, afite umutwe witwa: “Convention d'ouverture de crédit avec constitution d'hypothèque”. Ingingo yayo ya mbere iteganya ko ECOBANK RWANDA Ltd yemereye MICON REAL LINE Ltd inguzanyo ya 500.000.000 Frw, iya 2 ikerakana icyo iyo nguzanyo izakoreshwa n'uko Banki ifite uburenganzira bwo kubanza kwiyishyura kuri iyo nguzanyo imyenda MICON REAL LINE Ltd yari isanzwe iyibereyemo, ingingo ya 3 igateganya igihe cy'ayo masezerano, iya 5 ikibutsa ko umwenda remezo MICON REAL LINE Ltd yemerewe ungana na 500.000.000 Frw, ko inyungu zibariwe kuri 18% ku mwaka, ko kandi iyo nguzanyo ari iy'igihe kingana n'imyaka 10, ni ukuvuga kugeza ku wa 07/06/2026, naho ingingo ya 9 igateganya ko mu gihe uwafashe inguzanyo yaba ananiwe kwishyura ahaye Banki uburenganzira bwo kugurisha ingwate, kuyegukana, kuyicunga cyangwa kuyikodesha.

[16] Mu gusobanura amasezerano y'inguzanyo, abahanga mu mategeko bavuga ko amasezerano y'inguzanyo y'amafaranga ari amasezerano abantu bakorana umwe aha cyangwa se yemera guha undi amafaranga, uyahawe nawe akagira inshingano yeruye cyangwa se iteruye yo kuyishyura ku gihe bemeranyijwe habariyemo cyangwa se hatabariyemo n'inyungu<sup>2</sup>, bivuze ko iby'ingenzi muri ayo masezerano ari ukwemeranya ku mubare w'amafaranga, ku kigero cy'inyungu iyo zasezeranywe no ku gihe umwenda uzishyurirwamo.

[17] Urukiko rurasanga iby'ingenzi bigize amasezerano y'inguzanyo bigaragara mu masezerano yo ku wa 07/06/2016 hagati ya MICON REAL LINE Ltd na ECOBANK RWANDA PLC byuzuye, kuko muri ayo masezerano impande zombi zumvikanye ku ngano y'amafaranga y'inguzanyo (500.000.000 Frw), ku nyungu (18% ku mwaka) no ku gihe umwenda uzishyurirwamo (imyaka 10), hiyongeraho n'ingingo ijyanye n'uburenganzira bwa Banki ku ngwate mu gihe MICON REAL LINE Ltd yaba inaniwe kwishyura inguzanyo.

[23] Me Bimenyimana Eric akomeza asobanura ko ayo masezerano yashyizwe mu bikorwa, kuko mu bihe bitandukanye MICON REAL LINE Ltd yasabaga amafaranga muri ECOBANK RWANDA Plc ikayahabwa, atanga ingero z'uko byagenze ku mafaranga yagiye atangwa; ku wa 15/07/2016, MICON REAL LINE Ltd yandikiye ECOBANK RWANDA Plc iyisaba umwenda ungana na USD 186,562 irayahabwa, ku wa 28/07/2016 iha MICON REAL LINE Ltd umwenda wa USD 189,562 ni ukuvuga Frw 149,943,542 Frw kuri za ngwate zatanzwe mu masezerano yo ku wa 07/06/2016 kugeza ubwo umwenda MICON REAL LINE Ltd yari isanganywe wanganaga na 340.000.000 Frw uvuye kuri 250.000.000 Frw; ku wa 04/11/2016 ECOBANK RWANDA Plc yashyize kuri konti ya MICON REAL LINE Ltd umwenda wa 297.359.449 Frw uyu mwenda nawo ukaba ukomoka ku mwenda wa 250.000.000 Frw.
