Incamate y'ikibazo Exert Engineering Group Ltd yatsindiye isoko ryo kubaka stade ya Huye, biba ngombwa ko iha urwego rutanga isoko (Minisiteri ya Siporo n'Umucyo) ingwate yo kwishingira kurangiza isoko neza (performance security), maze Bank of Kigali Ltd aba ariyo iyaha iyo ngwate.

Ku wa 20/6/2012, Bank of Kigali Ltd yagiranye na Exert Engineering Group Ltd amasezerano y'inguzanyo y'umwenda ungana na 157.076.636 Frw, uhwanyeye n'agaciro k'ingwate yasabwaga. Mudenge wari umunyamigabane muri Exert Engineering Group Ltd na BAMUTESI Jacqueline, umugore we, bemeye kuyibera umwishingizi kuri iyo nguzanyo yatanzwe na Bank of Kigali Ltd, batangaho ingwate inzu yabo iri mu kibanza n° 1952/GAS/KIN gihereye i Gacuriro, Akarere ka Gasabo, mu Mujyi wa Kigali.

Mudenge yatanze ikirego mu Rukiko rw'Ubucuruzi, asaba ko Bank of Kigali Ltd yategekwa kurekura ingwate yahawe, kubera ko icyo yayitangiye kitakiriho kuko stade ya Huye yarangije kubakwa. Bank of Kigali Ltd na Exert Engineering Group Ltd bo bakavugaga ko umwenda ugihari, ko batasubizwa iyo ngwate. Yaba Urukiko rw'Ubucuruzi rwaregewe ndetse n'Urukiko Rukuru rw'Ubucuruzi rwajuririye ngo kuko hari amasezerano yo kwikiranura yabaye hagati ya Exert Engineering Group Ltd na Rwanda Housing Authority Mudenge atagizemo uruhare zemeje ko ikirego n'ubujurire bye nta shingiro gifite kuko Exert Engineering Group Ltd itigeze irangiza imirimo yo kubaka stade ya Huye.

Mudenge yajuririye bwa kabiri mu Rukiko rw'Ubujurire avugaga ko imirimo Exert Engineering Group Ltd yari yarumvikanye n'urwego rutanga amasoko mu masezerano, yayikoze ikarangira, akaba akwiye gusubizwa umutungo we, ko andi masezerano yo kwikiranura bakoze nyuma y'uko Rwanda Housing Authority isheshe amasezerano mu buryo bunyuranyije n'amategeko atakagombye kumugiraho ingaruka kuko yakozwe agahari.

Banki ya Kigali yatanze inzitizi yo kutakira ubujurire bwa Mudenge ivuga ko yasobanuye impamvu z'ubujurire nyuma y'igihe cy'ubujurire. Yongeye kandi ivuga ko Urukiko rw'Ubujurire nta bubasha rufite bwo kuburanisha ubujurire bwa kabiri bwa Mudenge kuko yatsinzwe ku mpamvu zimwe ku mpamvu zombi.

Mudenge yireguye avuga ko yajuririye ku gihe kandi atanga impamvu z'ubujurire bwe n'ubwo ibisobanuro byagiye byuzuzwa kuri buri mpamvu nyuma, akaba asanga ubujurire bwe bukwiye kwakirwa kuko asanga impamvu z'ubujurire bwe zaratangiye igihe.

Ku mpamvu z'ububasha bw'Urukiko rw'Ubujurire, Mudenge yireguye avuga ko ibyo yasobanuye mu nkiko zombi atari byo byafashweho icyemezo, ko uko abacamanza basobanuye impamvu zatumye atsindwa ari zimwe, ariko ko hakwiye kurebwa niba koko MUDENGE Emmanuel atararangije isoko.

Ibisobanuro binenga ingingo zo zatanzwe mu bihe byateganyirijwe ubujurire bidanzwe mu bihe by'ubujurire kuva ku muni urubanza rujurirwa rwasomeweho ntibituma ubujurire bw'uwajuriye buteshwa agaciro kuko itegeko ridadeganya ko ari umuhango simusiga cyangwa w'indemyagihugu keretse mu gihe uregwa mu bujurire agaragaje ko hari icyo bimwangiriza. Bityo, kuba Mudenge Emmanuel yaragaragaje inenge z'urubanza yajuririye n'impamvu zatumye ajurira n'abaregwa mu bujurire bakazireguraguraho nta kuntu ubujurire bwe bwatashwa agaciro cyane ko na kopi y'urubanza rujurirwa yabonetse nyuma y'amezi atandatu (6) kandi ari nayo yagombaga gushingiraho agaragaza ibyo anenga mu buryo burambuye, ndetse akanatanga ibisobanuro.

Bityo, ubujurire bwa Mudenge bukaba budakwiye kwakirwa kuko impamvu nyamukuru yatumye Mudenge atsindwa mu Rukiko rw'Ubucuruzi no mu Rukiko Rukuru rw'Ubucuruzi, ari ukuba Exert Engineering Group Ltd, itararangije imirimo y'isoko yari yatsindiye ryo kubaka stade ya Huye, ku buryo Mudenge wari watanze umutungo we ho ingwate yishingira umwenda w'ingwate yo kurangiza neza imirimo, yari yatanzwe na Bank of Kigali Ltd yashubizwa uwo mutungo we.

Ku wa 20/6/2012, Bank of Kigali Ltd yagiranye na Exert Engineering Group Ltd amasezerano y’inguzanyo y’umwenda ungana na 157.076.636 Frw, uhwanye n’agaciro k’ingwate yasabwaga. Mudenge Emmanuel wari umunyamigabane muri Exert Engineering Group Ltd na Bamutesi Jacqueline, umugore we, bemeye kuyibera umwishingizi kuri iyo nguzanyo yatanzwe na Bank of Kigali Ltd, batangaho ingwate inzu yabo iri mu kibanza n° 1952/GAS/KIN gihereye i Gacuriro, Akarere ka Gasabo, mu Muji wa Kigali.

[2] Mudenge Emmanuel yatanze ikirego mu Rukiko rw’Ubucuruzi, asaba ko Bank of Kigali Ltd yategekwe kurekura ingwate yahawe, kubera ko icyo yayitangiye kitakiriho kuko stade ya Huye yarangiye kubakwa. Bank of Kigali Ltd na Exert Engineering Group Ltd bo bakavuga ko umwenda ugihari, ko batasubizwa iyo ngwate.

[3] Mu rubanza n° RCOM 01084/2018/TC rwaciwe ku wa 13/12/2018, Urukiko rw’Ubucuruzi rwemeje ko ikirego cya MUDENGE Emmanuel nta shingiro gifite, rutegeka MUDENGE Emmanuel kwishyura Bank of Kigali Ltd amafaranga ibihumbi magana arindwi (700.000 Frw) y’igihembo cya Avoka no gukurikirana urubanza, rwemeje kandi ko Exert Engineering Group Ltd nta ndishyi igomba guhabwa.

[4] Mudenge Emmanuel yajuririyeye Urukiko Rukuru rw’Ubucuruzi, avuga ko Urukiko rw’Ubucuruzi rwirengagije ko imirimo yishingiye yagombaga gukorwa na Exert Engineering Group Ltd yarangiye, ko amasezerano yo kurangiza isoko ari nayo yatangiye ingwate, yarangiye na Exert Engineering Group Ltd ikishyurwa amafaranga arenga agaciro k’isoko, akaba akwiye gusubizwa umutungo we yatanzeho ingwate. Yavuze nanone ko habayeho amasezerano yo kwikiranura hagati ya Rwanda Housing Authority na Exert Engineering Group Ltd, aho bemeranyije ko Rwanda Housing Authority igumana 50% y’ingwate yo kurangiza imirimo neza, ariko akaba atagomba kumugiraho ingaruka kuko nta ruhare yayagizemo kandi ariwe watanze ingwate.

[6] Mudenge Emmanuel yajuririye Urukiko rw'Ubujujire avuga ko imirimo Exert Engineering Group Ltd yari yarumvikanye n'urwego rutanga amasoko mu masezerano, yayikoze ikarangira, akaba akwiye gusubizwa umutungo we, ko andi masezerano yo kwikiranura bakoze nyuma y'uko Rwanda Housing Authority isheshe amasezerano mu buryo bunyuranyije n'amategeko, aho bumvikanye ko Exert Engineering Group Ltd ihabwa 50% y'ingwate yo kurangiza imirimo, indi 50%, Rwanda Housing Authority ikayigumana, adakwiye guhabwa agaciro kuko yakozwe idahari kandi ariyo yari yarishingiye umwenda w'ingwate watanze na Bank of Kigali Ltd, ko muriyo ntaho bigeze bagaragaza ko imirimo itarangiye, ndetse ko Exert Engineering Group Ltd yahawe 416.499.078 Frw yari yarafatiriwe.

[7] Uburanira Bank of Kigali Ltd yatanze inzitizi ebyiri avuga ko ubujurire bwa Mudenge Emmanuel butakwakirwa kuko bwatanzwe impitagihe ku mpamvu y'uko ibisobanuro ku mpamvu z'ubujurire byatanzwe nyuma y'umwaka ubujurire butanzwe, no kuba Mudenge Emmanuel yatsinzwe ku rwego rwa mbere n'urwa kabiri ku mpamvu zimwe.

[8] Urubanza rwahamagawe kuburanishwa ku wa 21/12/2020, ariko uwo muni iburanishwa rirasubikwa kugira ngo ushinze gucunga igihombo (curateur de la faillite-liquidateur) cya Exert Engineering Group Ltd ashake umwunganizi wayo, ryimurirwa ku wa 6/1/2021, uwo muni urubanza ruburanishwa Mudenge Emmanuel ahagarariwe na Me Utazirubanda Gad, Bank of Kigali Ltd ihagarariwe na Me Rwagitare Fred, Exert Engineering Group Ltd ihagarariwe na Me Musore Gakunzi Valery.

Na none, dosiye y'urubanza igaragaza ko Exert Engineering Group Ltd nayo yatanze umwanzuro yiregura ku mpamvu z'ubujurire (mu mizi) za MUDENGE Emmanuel.

[20] Urukiko rw'Ubujurire rurasanga kugira ngo iki kibazo gikemurwe, ari ngombwa mbere na mbere kumenya niba kudatanga, mu gihe cy'ukwezi kumwe kuva urubanza rujuririrwa rwasomwe, urutonde rw'inenge zirimo (z'urubanza rujuririrwa), ibisobanuro kuri buri nenge, n'uburyo bigomba gukosorwa, ari inenge y'iremezo (irrégularité ou vice de fond) cyangwa inenge y'imyandikire (irrégularité ou vice de forme).

[47] Ushinzwe gucunga igihombo cya Exert Engineering Group Ltd asaba indishyi zinyuranye zingana na 2.000.000 Frw na 1.000.000 Frw yo gusiragizwa mu manza. Me Gakunzi Musore Valery nawe avuga ko kubera ko byabaye ngombwa ko Exert Engineering Group Ltd en liquidation ishaka Avoka ngo ayihagararire, mu gihe uwajuriye yatsindwa, Urukiko rwamutegeka kwishyura indishyi zirimo 1.000.000 Frw y'igihembo cya Avoka.
